

Current State of Supplier Diversity By the Numbers – Financial Overview

FY17

\$695.4M total spend \$18.6M diverse spend \$113.2M construction \$563.6M non-construction 2.7% overall FY22

\$687.2M total spend \$16.0M diverse spend \$122.3M construction \$548.9M non-construction 2.3% overall

FY23

\$654.1M total spend \$17.8M diverse spend \$144.5M construction \$509.5M non-construction 2.7% overall FY24 (YTD*)

\$498.8M total spend \$13.5M diverse spend \$92.6M construction \$406.2M non-construction 2.7% overall



State Certification Process

- Small number of suppliers registered as diverse suppliers with Department of Administration (n=1,470) – Impacts reporting
- Opportunities to go beyond ADMIN to recognize diverse businesses.
- What additional collaborative efforts are available to address the low volume of registered diverse suppliers?



Current State of Supplier Diversity Beyond Spend Percentages – A Different Approach

Total sourcing events in FY24	148
Diverse suppliers responding	1,641
Diverse suppliers invited	247
TGB suppliers responding	25 (10% response rate)
TGB suppliers awarded contracts	9 (<mark>36% of those who responded</mark>)

Barriers to Small Business Vendors

While we have identified several barriers, the barriers that we have direct control of will be addressed in FY25 include:

- **1.** Solicitation response timelines are unrealistic:
 - Review and potentially extend the response times for solicitations to allow adequate preparation by all suppliers, especially those with fewer resources.


2. Insurance requirement:

• Review and adjust insurance requirements to ensure they are proportional to the risk and scope, reducing barriers for smaller suppliers.

3. Bundling of multiple projects:

• Where feasible, break larger contracts into smaller, more manageable parts that can be handled by smaller suppliers. Encourage or mandate prime contractors to provide subcontracting opportunities to smaller businesses.
