2. You as the customer are solely responsible for knowing where your property is. We will build the fence where you instruct us to. We will not be responsible for moving it if it is on your neighbor's property.
3. Unless otherwise agreed to you must have the proposed fence line clear and ready for install.
4. Due to the volume of work we perform CFC cannot be responsible for obtaining any permits that may be required. It the customer's responsibility to check with your building and zoning offices as well as being aware of any restrictive covenants in your subdivision.
5. Due to site location and grade there may be gaps under the fence that cannot be avoided. Gates on sloped areas can also have gaps. Please discuss this with your installers before construction begins. **\*\*Fences follow the grade of the land unless otherwise requested during the estimate.\*\***
6. Treated lumber can be subject to warping, splitting or fading. Unless you apply a stain or other protective barrier this is a possibility. CFC uses the highest quality of lumber available to us from local mills however we cannot be held responsible for woods natural tendencies. We will provide you with replacement material in limited circumstances.
