What is the purpose of this contract and why is it needed? The purpose of this agreement with Rechtien International Trucks, Inc. is to facilitate the rental of a box truck, the provision of heavy-duty commercial truck preventative maintenance, purchase of parts, and the execution of repairs for the Broward College box truck used by Material Services. This truck is essential for relocating furniture, equipment, and handling various other deliveries collegewide. The College does not possess the equipment or resources to service this vehicle inhouse, these services are required on an as-needed basis throughout FY2024-2025.

What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2-6.34 was used, where there is no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. One quote was obtained to identify the best value for the required commodity or service.

What fund, cost center and line item(s) were used? Funds available in FD100, CC0037 (GL62500).
