CAEL supports adult learners by partnering with organizations to create career pathways that bridge education and employment. With expertise in credit for prior learning, strategic alignment with labor market needs, and policy development, CAEL helps build sustainable solutions that guide adults through lifelong learning and meaningful work.

Small purchase for Category One (\$0.00- \$10,000) per College Procedure A6Hx2-6.34 was used, where there are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. Membership dues, per the Florida Statute 119.01(3) requires that all financial, business and membership records held by the organization in relation to the individual(s) or organization(s) for whom a purchase order is being issued are to be considered public records and shall be subject to the provisions of Florida Statute 119.07

The students who have participated in the broader Credit for Prior Learning process—which includes Articulation Agreements, Credit-by-Exam, and the PLA Program—37% graduate within two years, and 56% graduate within three years. These outcomes highlight the effectiveness of CPL initiatives in accelerating student progress toward degree completion.
