Pursuant to Broward College Policy 6Hx2-1.14 and Procedure A6Hx2-1.14, Dr. Donald Astrab exercised the authority delegated by the Board to execute the contract amendment with Cobblestone Software for the Contract Insight Enterprise Contract Management Software utilizing the Miami Dade College contract ITN-2023-RM1-13. Fiscal Impact: \$640.00, Cumulative amount: \$66,640.00, Revenue: \$0.00

1.Describe the purpose of this purchase of goods, services, information technology, construction, or use of space. Add technical configuration services for department level approvals of non-contract items in the "Requests" module in CobbleStone. This will provide a custom workflow configuration of department head review for non-contract requests for Board approval.

2.Describe the competitive solicitation method used or, if none, the exemption relied on for bid waiver. The College procured this contract via bid waiver exception (piggyback) in accordance with FLDOE Rule 6A-14.0734(2)(c) and College Procedure 6AHx2-6.34, which provides exceptions to the requirement to solicit competitive offers.

3.Describe business rationale for the purchase and how it was procured.

(A) What is the benefit of the purchase. If there is an ROI, describe the ROI and how calculated. No, there was no return on investment anticipated. However, the use of a reliable CLM will help streamline the contracting process while aiding in improved productivity.

(B) How does the purchase support the Strategic Business Plan. Not applicable.

(C) If applicable, what is the rationale for the use of piggybacks, existing contract extensions, bid waivers in lieu of the College conducting a competitive solicitation. A team assembled by Procurement in the Fall of 2023 met with many vendors regarding contract lifecycle management (CLM) software. CobbleStone seemed the best overall fit for the College's needs. The College had the opportunity to piggyback on the Miami Dade College contract with CobbleStone thereby allowing the College to move faster to begin the implementation and configuration process.
