What is the purpose of this contract and why is it needed? The purpose of this maintenance warranty agreement is to provide the necessary technical support and software updates for the fuel dispensing system. This agreement will commence on 11/01/2024 and expire on 10/31/2025. The Temporary Certificate of Occupancy (TCO) was issued March, 28, 2020 for the fueling station project on Central Campus. This was under warranty and the warranty period is now expired, there was no warranty agreement prior to this limited maintenance agreement.

What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2-6.34 was used, where there is no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. This is imperative to the operation of the College. Service or commodities available from a single or sole source per College Procedure A6Hx2-6.34. This is imperative to the operation of the College.

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? Yes, June 2024 approved budget.
