Under old business, was the solar ordinance update, the pipeline ordinance discussion and the wind energy conversion systems ordinance update. Renewable Energy Coordinator Alice Henkel explained that at the February meeting of the Lee County Board, the Board approved the agreement with Chastain and Associates, LLC ("Chastain"). Under the County's agreement with Chastain, they will be taking over the preparation of the ordinances for wind, solar, and pipeline. Ms. Henkel stated she would be meeting with Chastain after this meeting to establish a plan for moving forward on those ordinances.

Also under old business was an update on the Memorandum of Understanding ("MOU") with the City of Amboy with regard to the proposed biogas facility. Ms. Henkel explained that the MOU had been drafted and forwarded to the attorney for the City of Amboy ("the City"). To her knowledge, no response from the City had been received at the time of the meeting.

Lastly under old business was the battery energy storage systems ordinance discussion. At the last meeting of this committee, Enel had provided a draft ordinance for battery energy storage systems. There were no comments from the committee regarding the draft. Ms. Henkel explained that Chastain would also be assisting the County with developing an ordinance for battery energy storage systems.

There was no other old business.

There was no new business.

Under comments from visitors, John Nicholson said that LCIDA and Blackhawk Hills Regional Council have concerns about how utility solar developments located near municipalities may affect future growth of that municipality. They would like to see the County amend its solar ordinance so that it prohibits a special use permit for solar form being granted without a municipality's agreement within one (1) mile of the city limits if the land is either identified as commercial/industrial in the municipality's current land use plan; or, if there is evidence of development investment having already taken place such as creating a subdivision or building out infrastructure. Mr. Nicholson provided a copy of an e-mail from LCIDA stating same to Ms. Henkel that she will provide to Chastain.

There was no other business.

There was no executive session.

The next meeting will be April 7, 2022, at 9:00 a.m.
