SUBJECT: To seek approval to appoint William Green as Project Director for Healthcare for the Homeless (HCH) grant.

BACKGROUND

Broward Health's HCH program has been in existence since 1993 and has received HRSA Health Center funding for more than 20 years. The HCH program provides primary and urgent medical care, diagnostic exams/ screenings, behavioral health counseling, vision care, prophylaxis, and emergency oral health services. The HCH program is federally funded by the Health Resources and Services Administration.

As per 42 USC 254b: Health centers, Section (3) Requirements, Subsection (H)(ii), the center's governing board must "approve the selection of a director for the center who shall be directly employed by the center." The HCH program is requesting William Green be appointed to the Project Director role. Mr. Green has provided oversight to the HCH program since he commenced his position as Executive Director of Community Health Services in 2020. Mr. Green has extensive experience in federal grant management and oversight, which Broward Health believes is essential in ensuring the success of the Healthcare for the Homeless program going forward.

ACTION/PROJECT DESCRIPTION

To seek approval to appoint William Green as Project Director for HCH grant.

FINANCIAL/BUDGETARY IMPACT

There are no Fiscal Impacts or changes to the current Budget related to the appointment of a Project Director.

JUSTIFICATION

The role of Project Director is a grant requirement. Appointing Mr. Green to the role of Project Director will ensure that Broward Health is compliant, and thus eligible to continue receiving funding from the Health Resources and Services Administration's HCH grant.
