**SUBJECT:** Approval to renew a two-year employment agreement up to the 79<sup>th</sup> percentile with Dr. Yordanka Reyna to continue to provide Advanced Heart Failure and Transplant Cardiology Services.

**BACKGROUND**

The North Broward Hospital District, d/b/a Broward Health is seeking to renew a two-year employment agreement up to the 79<sup>th</sup> percentile with Dr. Yordanka Reyna. Dr. Yordanka Reyna obtained her Doctor of Medicine from Ross University School of Medicine, Dominica, West Indies in 2008. She then completed her Internal Medicine Residency at Cleveland Clinic Weston, Florida in 2011, followed by a Cardiovascular Medicine Fellowship at the same location in 2015. She completed an Advanced Heart Failure and Transplantation Fellowship at Cleveland Clinic Foundation, Cleveland, Ohio in 2015. Dr. Reyna is an experienced physician with multiple board certifications in IM, National Board of Echocardiography, Cardiovascular Disease and Advanced Heart Failure and Transplant Cardiology.

Dr. Reyna joined Broward Health Physician Group in August of 2020 and has been instrumental growing and expanding the cardiovascular service line to further serve the community. She is currently the only employed Fellowship Trained Advanced Heart Failure and Transplant Cardiologist within the Broward Health service area. The specialty includes care and treatment of patients with complex diagnoses and management of difficult, advanced and chronic heart failure, high risk cardiac surgical and percutaneous interventions, cardiac transplantation and end of life care and management. Dr. Reyna has been instrumental in furthering the high quality of services within the Cardiology service line and it is imperative that we renew her agreement to continue to maintain and expand those services to the patient population and Broward Health physician community.

### **ACTION/PROJECT DESCRIPTION**

We are requesting that the Board of Commissioners approve the renewal of a two-year contract with Dr. Reyna up to the 79<sup>th</sup> percentile. Broward Health is requesting that the Board of Commissioners authorize the President/CEO to approve to enter into a renewal agreement with Dr. Yordanka Reyna for a 2-year term. An independent third-party appraisal report determined that the proposed arrangement is commercially reasonable, and the compensation is within fair market value (FMV). Specifically, the proposed base compensation approximates the 33rd percentile for regional benchmark data, with an overall maximum compensation up to the 79<sup>th</sup> percentile.

### **JUSTIFICATION**

Broward Health has documented and objectively determined that there is a legitimate business purpose for the services of a qualified physician to provide clinical care at Broward Health Medical Center.

The community needs assessment identifies this specialty as a critical priority with a shortage of (12.5) cardiologists needed by 2025 in the Broward Health Medical Center region.

Dr. Reyna joined Broward Health Physician Group in August of 2020. She is currently the only employed Fellowship Trained Advanced Heart Failure and Transplant Cardiologist within the Broward Health service area. The specialty includes care and treatment of patients with complex diagnoses and management of difficult, advanced and chronic heart failure, high risk cardiac surgical and percutaneous interventions, cardiac transplantation and end of life care and management. Dr. Reyna has been instrumental in furthering the high quality of services within the Cardiology service line and it is imperative that we renew her agreement to continue to maintain and expand those services to the patient population and Broward Health physician community.
