SUBJECT:

Request for authorization to execute a 10-year lease of real property.

BACKGROUND

The District wishes to lease real property located at 1527 SW 1st Avenue, Fort Lauderdale, Florida, to house the District's corporate offices and meeting space..

ACTION/PROJECT DESCRIPTION

Requesting Board approval to authorize the District to enter into a 10-year lease of real property located at 1527 SW 1st Avenue, Fort Lauderdale, Florida, for \$3,852,094.56 over the 10-year term and with capital improvements not to exceed \$6,000,000, for a total cost of up to \$9,852,094.56.

FINANCIAL/BUDGETARY IMPACT

Lease payments of \$3,852,094.56 over the 10-year term with capital improvements not to exceed \$6,000,000, for a total cost of up to \$9,852,094.56.

JUSTIFICATION

In 2014-2015, the District moved its corporate offices from downtown Fort Lauderdale to its current location at 1800 NW 49th St, Fort Lauderdale, Florida ("Spectrum Offices"). Over the course of the last 7-8 years, it has become apparent that there is a need for the District to relocate its corporate offices back to the downtown Fort Lauderdale area to further enhance operations and strategic initiatives. The lease of the real property would achieve this objective.

STAFF RECOMMENDATION

Therefore, it is requested that the Board of Commissioners of the North Broward Hospital District authorize the District to enter into a 10-year lease of real property located at 1527 SW 1st Avenue, Fort Lauderdale, Florida, for \$3,852,094.56 over the 10 -year term of the lease and for capital improvements not to exceed \$6,000,000.
