**Topic: ESTIMATED ACTUAL - 2022 Tax Levy (FY 2023)**

Attached is the County of Lee, Illinois 2022 (FY 2023) Tax Levy Ordinance that is being placed on file today. Final approval will be at the November 20, 2022, Board meeting. The total levy requested is \$8,272,575 which is \$484,672, or 6.22% more than last year. The increase is primarily due to the annual CPI of 5% and estimated new property assessed value of \$8,217,552.

The County's proposed 2022 tax rate will be approximately \$0.8960 per hundred dollars of EAV, up from \$0.8689 in 2021. The following table compares the two years' levies and tax rates:

BE IT ORDAINED that the sum of eight million, two hundred seventy-two thousand, five hundred seventy-five dollars (\$8,272,575) the aggregate of the levies detailed below is hereby levied and assessed on all the taxable property in the County of Lee, Illinois according to the value of said property as assessed and equalized for state and county purposes for the year 2022, and that the County Clerk be directed to extend a tax upon the properties.
