Topic: EXECUTIVE COMMITTEE RECOMMENDATION - 2022 Tax Levy (FY 2023)

Attached is the County of Lee, Illinois 2022 (FY 2023) Tax Levy Ordinance that is being placed on file today. Final approval will be at the November 20, 2022, Board meeting. The total levy requested is \$8,424,200 which is \$636,297 (8.17%) more than last year. The increase is primarily due to the annual CPI of 5% and estimated new property assessed value of \$8,217,552.

The County's proposed 2022 tax rate will be approximately \$0.9124 per hundred dollars of EAV, up from \$0.8689 in 2021. The following table compares the two years' levies and tax rates:
