## **PURPOSE**

Board Policy 1A.1 Minnesota State Colleges and Universities Organization and Administration, Part 6. Board Policies and System Procedures requires board review and approval of proposed board policy changes and that each board policy is reviewed at least once every five years.

The proposed amendment consists of (1) adding "Active Service Member Status" to the title and relevant parts, (2) adding Part 2. Authority to identify the Minnesota statutes that affect the definition of "veteran, (3) adding the definition of "active service member", and (4) updating the definition of "Veteran".

# **Active service member**

A person actively serving in state active service, federally funded state active service, or federal active service.

### **Graduate or Professional Programs**

Post-baccalaureate educational programs leading to graduate certificate, master's, specialist, or doctoral degrees offered by Minnesota State universities.

### Veteran

A person who is currently serving or has served in the United States Armed Forces and has been <u>separated</u> under honorable conditions.

### Part 43. Policy

34 Minnesota State universities shall recognize an applicant's veteran status or active service member status as a positive factor in determining whether to grant admission to a graduate or 35 36 professional academic degree program.

## Part 54. Annual Report

- 39 By January 15 of every year, each Minnesota State university shall submit a report to the
- 40 system office on the number of veterans who applied for admission to a graduate or
- 41 professional academic degree program and the number accepted during the previous fiscal year.
