Police

The State of Alaska is still maintaining the Covid-19 regulations for state residents to continue social distancing and the use of masks when indoor public places. DHSS briefing the current State of Emergency with COVID19 Education of Alaska State Health Mandates to the public as directed by the Commissioner of DHSS.

SPDPS is assisting the St. Paul Community & St. Paul Unified Command in providing updated educational material to those traveling to St. Paul from outside the community. The 14-day quarantine is still mandatory for all traveling to St. Paul.

St. Paul Dept. of Public Safety has been directing more calls for services that lean towards civil infractions and violation matters to be addressed by the Aleut Tribal Court. St. Paul Dept. of Public Safety is continuing communication to better utilize pre-existing Tribal programs.

Public Safety has added three new 2020 Chevy Silverado's to its fleet. Two emergency police vehicles outfitted as per the State of Alaska emergency vehicle requirements and a single cab pickup being assigned to the Harbor Master office.

Dispatch

St. Paul Emergency Dispatch has hired temp part time dispatchers Kayla Stepetin and Marcella McCoy both are in the process of completing dispatch training. is still in the process of a written Information Exchange Agreement (MOU) for CJIS, ASPIN information and compliance with the State of Alaska Department of Public Safety. St. Paul Dept. of Public Safety Policy and Procedure updates pending this MOU with Department of Public Safety.

EMS / Ambulance

St. Paul Dept. of Public Safety has hired an EMS Director, Kaitlan Silva. Mrs. Silva is married and has four children ages 8, 6, 4 and 7 months of age. Kaitlyn has already completed the State to State transfer of her EMT certification, registering her within the State of Alaska as a licensed EMT. Kaitlan has a Degree in Emergency Management.

As of 09/11/20 Public Safety EMS Dept. has had a total of 97 medicals and 34 medivacs for 2020.



EMS is seeking volunteers to become ETT certified or become drivers and lift assistants. Volunteers will be compensated \$100.00 per medical run. St. Paul Dept. of Public Safety has rescheduled the training for CPR and Basic First Aid, the date for this training is to be determined.

EMS volunteers are now equipped with PPE and all have been fitted tested with N95 masks to help protect against airborne virus COVID19. Public Safety received an Alaska Public Health Alert giving Officers and EMS volunteers direction and guidance for the safe handling of deceased bodies caused or possibility caused by COVID-19. This enables Public Safety Officers and EMS volunteers to prevent exposure of self and others and to better assist the community of St. Paul and the South-Central Clinic.

Fire Department / SAR


SPVFD & SPDPS / EMS responded to a house fire at #43 Church Street. SPVFD did a follow-up inspection and disposed of any possible hazardous materials. There were no reports of Fire Dept. Volunteers or civilians injured. St. Paul Dept. of Public Safety and St. Paul EMS were also on scene.

Harbor Master

The City Harbor Officer has been tasked with dual roles as assigned, assisting the Public Works Department when needed and Public Safety Dispatch as a fill in Emergency Dispatcher. As stated, the Harbor Master received one of the single cab 2020 Chevy Silverado's for Harbor Master duties.

COVID CALLS REPORTED TO PUBLIC SAFETY

Calls from 07-30-20 until 09-15-20

- 7-31-20 (355) Report of GCI employees who are on quarantine attempting to go to the Tribal Store. L. Nutter advised they can not enter. Public Safety made contact and advised them of what is allowed and not allowed during quarantine. Public Safety gave them the store number for food to be ordered and delivered.
- 8-06-20 (359) Report of male party on quarantine having gone to the Tribal Store. He did not go inside but was outside in parking lot area. Male party was gone from store upon officer arrival. Male party was advised by Public Safety of what is allowed and not allowed during quarantine.
- 8-12-20 (363) Anonymous report of 2 males at the house of someone under quarantine. One male party was stated to have been seen entering the residence. Public Safety attempted to locate both parties as well as the party under quarantine. Was unable to locate parties on said day. Messages were left with all parties.
No more calls on these 3 individuals.
- 8-17-20 (373) Public Safety and Harbor Master escorted several members of a boat crew from airport to harbor. Passengers were not cleared to land in Saint Paul Island as paperwork was not received in a timely manner.
- 9-03-20 (399) Major medical emergency on board F/V. EMS and Officers were in proper PPE, treated and transported patient to waiting Medivac plane.
- 9-13-20 (413) A community member reported a person who is in quarantine going to the Clinic. I advised this is not a violation of quarantine. People who are in quarantine, if a medical need, can go to the clinic if they call ahead and wear a mask. Dispatch stated they would advise the community member. I also advised Dispatch to have the community member go onto the City of Saint Paul website and review what is and is not allowed.
