Recommendation that the Broward College District Board of Trustees authorize the standard agreement (purchase order) with Lindsay Garritson for guest artist services for the Rosemary Duffy Larson Classical Music Series and Music Program. Fiscal Impact: \$2,000.00.

What is the purpose of this contract and why is it needed? Performance fees for Rosemary Duffy Larson (RDL) Classical Series. This is a series of classical music concerts performed for the College community and the greater South Florida area. Students are exposed to performers of world-class caliber through use of a semi-endowed fund created expressly for the purpose. Annually over 600 students take advantage of this co-curricular experience.

What procurement process or bid waiver was used and why? The procurement process for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2-6.34 was used. There are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold.
