



## EXECUTIVE SUMMARY

**Recommendation that the Broward College District Board of Trustees authorize the standard agreement (blanket purchase orders) with Eric Camarda dba No Wanna Iguana for wildlife trapping, relocation & removal services as needed collegewide for FY2024-2025. Fiscal Impact: Estimated \$35,000.00**

**What is the purpose of this contract and why is it needed?** For wildlife trapping, relocation and removal services as needed collegewide for FY2024-2025.

**What procurement process or bid waiver was used and why?** Informal competitive process per College Procedure A6Hx2-6.34, for purchase from \$10,001 up to Category Two (currently \$35,000) as defined in Section 287.017(2), Florida Statutes. The requesting department shall obtain three (3) quotes providing the best value for the required commodity or service. However, a statement of work (SOW) must be provided if services are requested. The award shall go to the lowest priced responsive/responsible vendor who meets the requirements. The supplier selected Eric Camarda DBA No Wanna Iguana.

**Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting?** Yes, June 2024 approved budget.

**What fund, cost center and line item(s) were used?** Funds available in FD100, CC0143 (GLC 64500).

**Has Broward College used this vendor before for these products or services?** Yes.

**Description of Services:**

They will trap live invasive and non-evasive species and relocate them off campus back into the wild, this service helps to reduce any property damage from these species which could compromise our infrastructure. All activities will comply with applicable laws, rules and regulations, including Florida Fish & Wildlife rules and regulations.
