TOPIC: Community Collage of Aurora Additional Spending Authority for the Educational Advisory Board (EAB) Contract

RELATIONSHIP TO THE STRATEGIC PLAN:

Transform the Student Experience

Implement and scale-up proven student-support mechanisms that partner with students to confront and overcome educational barriers

EXPLANATION:

Community College of Aurora would like to add the Student Success Collaborative Intelligence Module/Predictive Analytics to the Educational Advisory Board (EAB) contract. The EAB contract is a system-wide contract and includes the primary product EAB Navigate, which is used for new student onboarding, student advising, student early alerts and student communications at each college. An additional product, Student Success Collaborative Intelligence Module/Predictive Analytics, is already in use by Arapahoe Community College, Pueblo Community College, Community College of Denver, and Red Rocks Community College. CCA has determined that this module would be useful to them as well. Predictive Analytics uses machine learning to analyze at least 8 years of college data, stored in Banner, to custom configure a predictive model unique to the college. The model helps the institution understand cohort and individual student risk factors and plan interventions and support services accordingly. The model is continually updated based on student data and EAB's data science team and research.

The cost to CCA to add Predictive Analytics includes a one-time implementation fee of \$15,000 and \$10,000 annually for the next three years running co-terminus with the overall EAB contract from March 23, 2023 through March 22, 2026. This is an overall increase to the contract of \$45,000. The impact on the current EAB contract, which was previously approved by the Board, is as follows:

RECOMMENDATION:

Staff recommends the approval for CCCS to proceed with the amendment to the EAB contract adding the Student Success Intelligence Module/Predictive Analytics on behalf of the Community College of Aurora and thus increasing the overall EAB Contract by \$45,000. Staff also recommends that the Board delegate to the System Vice Chancellor of Finance and Administration the authority to sign all related contract documents on the condition that all Board and State processes are followed.
