## 6. TOPIC OF DISCUSSION

- 6.1. BHPG, Approval to renew a two-year employment agreement up to the 80th percentile with Dr. Fernando Narvaez to provide Family Medicine and Chief of Staff services at Broward Health Imperial Point (Presenter – Alan Whaley, EVP, Chief Operating Officer)

**MOTION** It was *moved* by Commissioner Angier, *seconded* by Commissioner Berry, that:

The Finance Committee recommend that the Board of Commissioners of the North Broward Hospital District authorize the District to renew a two-year employment agreement up to the 80th percentile with Dr. Fernando Narvaez to provide Family Medicine and Chief of Staff services at Broward Health Imperial Point, as presented.

Motion *carried* unanimously.

- 6.2. BHPG, Approval to amend and extend an employment agreement with Dr. Naaz Fatteh for compensation up to the 87th percentile to provide Infectious Disease Clinical and GME Program Directorship Services at Broward Health Medical Center (Presenter – Alan Whaley, EVP, Chief Operating Officer)

**MOTION** It was *moved* by Commissioner Berry, *seconded* by Commissioner Angier, that:

The Finance Committee recommend that the Board of Commissioners of the North Broward Hospital District authorize the District to amend and extend an employment agreement with Dr. Naaz Fatteh for compensation up to the 87th percentile to provide Infectious Disease Clinical and GME Program Directorship Services at Broward Health Medical Center, as presented.

- 6.3. BHPG, Approval to renew an employment agreement with compensation above the 90th percentile with Dr. Louis Cioci to provide Cardiology services at Broward Health Imperial Point (Presenter – Alan Whaley, EVP, Chief Operating Officer)

The Finance Committee recommend that the Board of Commissioners of the North Broward Hospital District authorize the District to renew an employment agreement with compensation above the 90th percentile with Dr. Louis Cioci to provide Cardiology services at Broward Health Imperial Point, as presented.

- 6.4. BHPG, Approval to renew an employment agreement with compensation above the 90th percentile with Dr. Mehmet Hepgur to provide Hematology Oncology Clinical and GME

**MOTION** It was *moved* by Commissioner Angier, *seconded* by Commissioner Berry, that:

The Finance Committee recommend that the Board of Commissioners of the North Broward Hospital District authorize the District to renew an employment agreement with compensation above the 90th percentile with Dr. Mehmet Heggur to provide Hematology Oncology Clinical and GME Program Directorship Services at Broward Health North, as presented.

Motion *carried* unanimously.

6.5. BHC, Approval to waive the Competitive Bidding Process, Designate HealthStream as Legacy System, and approve the extension of the HealthStream Master Services Agreement for an additional 5 years for a total amount of \$3,550,519.30 (Presenter – Mark Sprada, SVP, Chief Human Resource Officer)

Mr. Sprada provided a high-level overview of HealthStream, a web-based learning management platform designed to help healthcare organizations create, organize, and manage regulatory compliance training. Noted that HealthStream has provided service to the District since 2008. Additionally noted that the District is currently in the process of an import upgrade which Lawson integrates with HealthStream and, HealthStream has locked in 2018 pricing.

Discussion ensued and it was voiced that the bidding process should be followed and the need to compare HealthStream to other competitors, as last comparison was conducted on or about 2012 – 2014.

**MOTION** It was *moved* by Commissioner Berry, *seconded* by Commissioner Angier, that:

The Finance Committee recommend that the Board of Commissioners of the North Broward Hospital District waive the competitive bidding requirements, designate HealthStream as a Legacy System, and authorize the District to extend the HealthStream Master Services Agreement for five (5) years for a total amount of \$3,550,519.30, as presented.

- 6.6. Broward Health Design, Construction and Real Estate, Approval for capital funding to make repairs to the existing BHMC Employee Parking Garage related to the city required 40-year electrical and structural survey and to extend the life of the garage structural integrity (Presenter – David Clark, SVP, Operations)

**MOTION** It was *moved* by Commissioner Angier, *seconded* by Commissioner Berry, that:

The Finance Committee recommend that the Board of Commissioners of the North Broward Hospital District authorize the District to repair the existing Broward Health Medical Center Employee Parking Garage related to the city required 40-year electrical and structural survey and to extend the life of the garage and the structural integrity up to a projected budget of \$6,200,000., as presented.

Motion *carried* unanimously.
