EMERGENCY CITY COUNCIL MEETING  
AUGUST 10, 2021

The emergency meeting was called to order by Mayor Merculief at 4:36 pm. Councilmembers present were Raymond Melovidov, Dimitri Zacharof, Victor Clarey, Joseph Kozloff, Jason Bourdukofsky and Daniel Porath. A quorum was established. This meeting was broadcast on KUHB.

Cmbr Bourdukofsky moved to approve the agenda, seconded by Cmbr Clarey. Motion carried by voice vote.

Cmbr Clarey moved to approve Emergency Ordinance 21-100 Emergency Ordinance 21-100 Proclamation of Emergency “Hunker Down” Order To Prevent The Spread Of Covid-19 Throughout Saint Paul Island, seconded by Cmbr Melovidov. On August 9, 2021 Mgr Zavadil was informed of a positive rapid COVID-19 test. This test was performed on a recent traveler who was doing the post 2-5 day arrival test. 2 tests we performed both were positive. A PCR test was also down and sent out to the lab. A Unified Command meeting was held to discuss what needed to be done and what actions needed to be taken based on the likelihood of the case being the delta variant and the number of close contacts in the community. A close contact is considered to be someone that is in close vicinity for 15 minutes or more within 6ft. All together were about 44 people. Mgr Zavadil and Case Manager Mandregan spoke to Dr. Cooper yesterday and recommended to test all close contact with PCR tests. All the close contacts have been tested today with both rapid and PCR test. All the tests went out on RAVN to the lab in Anchorage. So far, all the PCR tests have come back negative with the exception of the person that tested positive. All close contacts and those they reside with will be in quarantine for 14 days. Delta variant makes up 90% of the cases in Alaska right now. Hunker down will go into effect beginning August 10, 2021 at 6:00 pm for 14 days ending on August 24, 2021 at 6:00 pm. Everyone on Saint Paul Island shall stay at home as much as possible. All individuals regardless of vaccination status permitted to travel, but who do not qualify for Essential Services or Critical Infrastructure workforce, are required to self-quarantine for 10 days upon arrival. Anyone exhibiting symptoms should be tested as soon as possible.
