Alabama Becomes 32nd Active Compact Jurisdiction

On October 7, Alabama became the 32nd active member of the Physical Therapy Compact. Starting on that date, any eligible physical therapist or physical therapist assistant could purchase a compact privilege for the State of Alabama. In addition, any Alabama licensee whose home state is Alabama could purchase a compact privilege in any of the other 31 active jurisdictions.

With the recent enactment of the compact legislation in Alaska and Rhode Island, there are currently seven additional member states that are still working on implementing the requirements needed to become an active jurisdiction. Those states include Alaska, Connecticut, Kansas, Maine, Pennsylvania, Rhode Island, and Vermont.
