- Data shows that students who miss 2-4 days in September often go on to miss as much as a month of school.
- Chronic absenteeism by the 3rd grade generally results in students not showing proficiency in reading and math.
- When students improve their attendance rates, they improve their academic prospects and chances for graduating.
- The Attendance Committee is working on a Self Assessment Tool for tackling attendance issues within the schools.
- Letters and phone calls from the superintendent will be going home for habitual/chronic absenteeism.
