### MercyOne Balanced Scorecard measures defined Purpose

- Preventable hospitalizations: AHRQ measure of Ambulatory Care Sensitive Condition (ACSC) inpatient admissions a defined set of clinical conditions "sensitive" to ambulatory care interventions. Measured monthly (rolling 9 months) for Medicare potients attributed to Trinity Health Medicare ACOs (and for dually-enrolled, who also have Medicaid as a secondary payer).
  - Source is claims data (60-90- day lag) and will be available at Trinity Health and Regional Health Ministry level.
- Racism: A Public Health Crisis –The total percent of managers and above who've completed the course.\*
- Cultural Proficiency Training The total percent of colleagues who've completed the Cultural Proficiency: Our Journey to Health equity course on Pathways or HealthStream.\*
- \*Central lowa will not be included in FY23.

#### Iowa Senate unanimously passes REH licensure bill

The Iowa Senate unanimously passed the amended <u>rural</u> <u>emergency licensure</u> bill establishing the new hospital designation.

Rural hospitals choosing to opt in to the new category will continue to furnish emergency department services, observation care and, if a hospital chooses, other specified outpatient medical and health services. Services rendered must not exceed an annual per-patient average of 24 hours. For eliminating inpatient care, rural

emergency hospitals will be paid the applicable Outpatient Prospective Payment System rate plus 5% and a monthly facility payment.

MercyOne is pleased to have worked closely with Senator Charles Grassley at the federal level for initial passage of this law, followed by this as a continued priority to pass at the state level to ensure lowa hospitals could choose this as an option if best for its community and health care needs.

#### Genesis Ambulance Donates Rig to Ukraine

An ambulance that helped save lives in the Quad Cities for more than six years is now helping injured soldiers and civilians on the frontlines of the Russo–Ukranian War.

Genesis Ambulance donated the retired rig to United States
Ambulances for Ukraine. The lifesaving gift traveled more than 5,000 miles to war-torn Kyiv and was immediately put into service to evacuate the wounded.

"An ambulance at the end of its life here can mean the difference between life and death for somebody in Ukraine," said Adam Haut, Genesis ambulance director.
