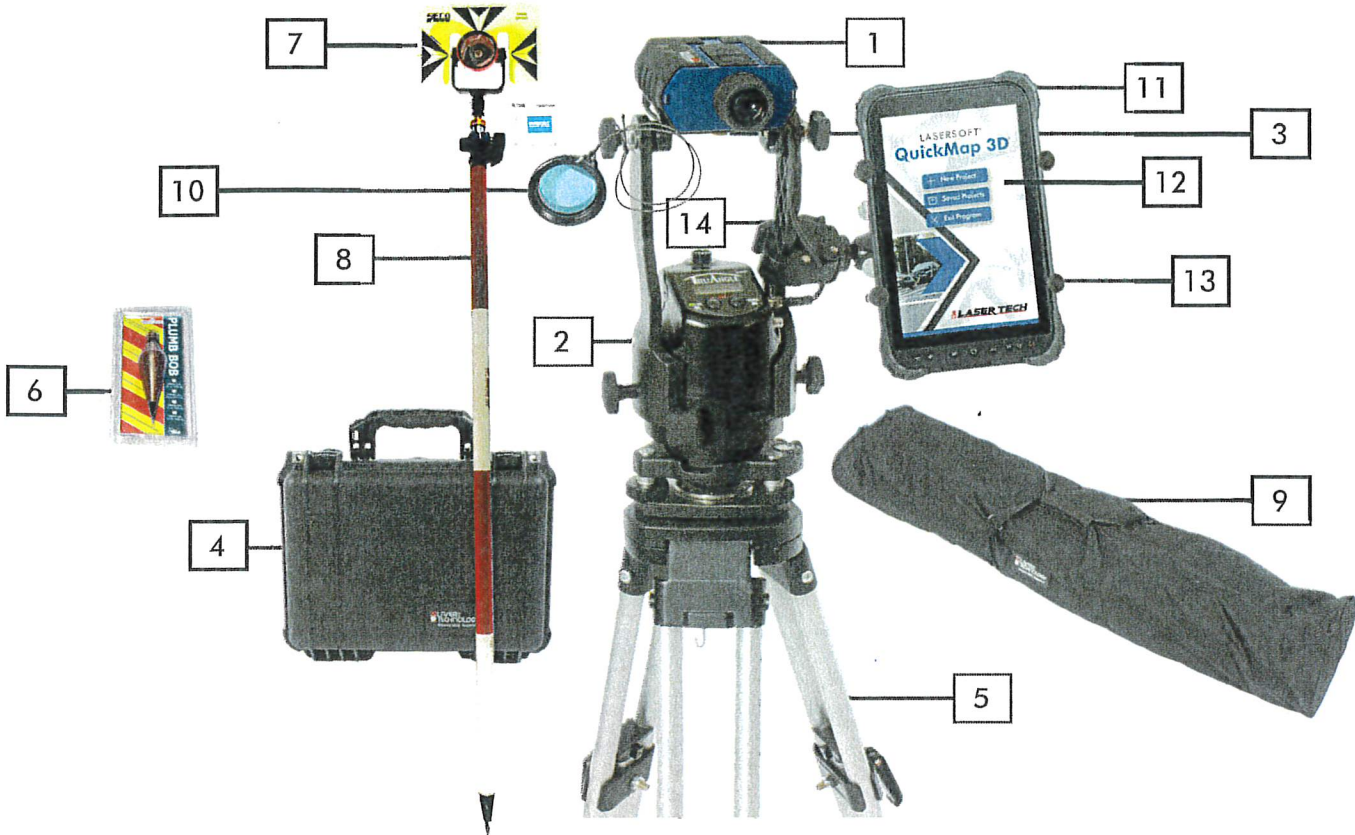

Request an additional \$21,000.00 from Capital Expenses for the purchase of four (4) new squads. New squad prices rose \$5444.12 each from the FY22 cost of \$34,481.76 per squad.

During the budget process for FY23, it was not known that the price of squad cars would rise over \$5400.00 each. The price for a 2023 Ford Explorer - Police Package rose to \$39,922.88 each from the FY22 price of \$34,481.76 per squad. The increased amount is \$5444.12 for each vehicle. As a further frame of reference, the FY21 price for a Ford Explorer - Police Package was very close to FY22 pricing as it was \$34,163.90. Therefore, the FY23 Capital Plan for squads is short approximately \$21,000.00.
