






# On average how many prescriptions do you fill in a week?


# On average how many vaccines are given yearly at your location?


# How many immunizations does your pharmacy give on an average day during the height of flu shot season?










# If your pharmacy does COVID-19 testing, do you feel this has negatively impacted your pharmacy workflow?






# Do you feel you have adequate staffing to practice pharmacy safely?


# Do the board of pharmacy rules allow you to delegate appropriate tasks to technicians?








# Do you feel your company gives you the tools you need to make patient safety a priority?


# How often do you come in early/stay late to keep up with pharmacy workload demands?


# Do business expectations interfere with your ability to practice pharmacy safely?


