BACKGROUND

The North Broward Hospital District, d/b/a Broward Health is seeking to renew an employment agreement with total maximum compensation up to the 78th percentile with Dr. Paul Agtarap. Dr. Paul Agtarap obtained his Doctor of Medicine from the University of the City of Manila in 1996. Dr. Agtarap completed a Residency in Internal Medicine at Palmetto General Hospital in 2021. Dr. Agtarap is an experienced, Florida Licensed and Board-Certified physician who has been employed by Broward Health since 2021.

It is critical for the community and healthcare system to employ internal medicine specialists to meet the current and future growing demands. As a safety net hospital, the District is obligated to provide services to meet the community needs.

ACTION/PROJECT DESCRIPTION

We are requesting the Board of Commissioners approve renewing an employment agreement with Dr. Paul Agtarap with compensation up to the 78th percentile.

Broward Health is requesting that the Board of Commissioners authorize the District to renew an employment agreement with Dr. Paul Agtarap, for a two-year term. An independent third-party appraisal report determined that the proposed agreement is commercially reasonable, and the compensation is within fair market value (FMV).

JUSTIFICATION

Broward Health has documented and objectively determined there is a legitimate business purpose for the services of a qualified physician to provide clinical services in the medical specialty of Internal Medicine at Broward Health.

The community needs assessment identifies this specialty as a critical priority with a shortage of (104) internal medicine providers needed by 2025 in the Broward Health Medical Center region. Recommendations from the Community Needs Assessment suggest that access to specialty care is a priority throughout Broward Health service areas.

Dr. Paul Agtarap will continue to provide primary care services to meet community and healthcare system needs.

STAFF RECOMMENDATION

Therefore, it is requested that the Board of Commissioners of the North Broward Hospital District authorize the District to renew an employment agreement with compensation up to the 78th percentile with Dr. Paul Agtarap to provide Internal Medicine services at Broward Health Medical Center.
