**SUBJECT**: Seeking approval for retroactive financial assistance using an electronic screening software

tool to determine eligibility for March 2020 thru May 2023 (PHE)

#### **BACKGROUND**

North Broward Hospital District d/b/a "Broward Health" provides financial assistance to patients who receive emergency care and/or other medically necessary services in a Broward Health Facility and who satisfy the eligibility requirements for Financial Assistance under policy GA-018-055 (Financial Assistance Policy or "FAP).

Broward Health recognizes that a portion of the uninsured population will not engage in the traditional application process. To that end, seeking approval to retroactively screen this patient population for Financial Assistance eligibility via an electronic screening software tool.

• This predictive scoring tool utilizes public data including estimates for income and household size and compares against the Federal Poverty Guidelines ("FPG").

#### **ACTION/PROJECT DESCRIPTION**

Identifying Presumptive FAP Determinations via Electronic Screening Software Tool

- Broward Health recognizes that a portion of the uninsured patient population may not engage in
  the traditional financial assistance application process. If the information required by this policy
  is not provided by the patient, Broward Health may utilize an automated predictive scoring tool
  provided by a third-party vendor to identify patients that qualify for financial assistance under
  this policy. The screening process utilizes public data and includes estimates for income,
  household size, and compares against the FPG.
- The automated predictive scoring tool will be deployed for those patients that received emergency care and/or other medically necessary services during the PHE (March 2020 thru May 2023) and where there is no identified third-party insurance and all other eligibility and payment sources have been exhausted. The data returned from this automated predictive scoring tool will constitute adequate documentation of financial need under this policy, including instances where documentation is not available from the patient.

## **JUSTIFICATION**

To ensure financial assistance eligibility during the PHE period was provided to those individuals that met the criteria for FAP GA-018-055.

## **STAFF RECOMMENDATION**

Therefore, it is requested that the Board of Commissioner of the North Broward Hospital District approve the retroactive screening of those patients without 3<sup>rd</sup> party insurance for financial assistance eligibility for the period of March 2020 thru May 2023 (PHE).
