The next property on the radar for the County is on West 4th Street in Dixon and eventually the property at Route 30 and Highway 251.

#### Community Service Program 2<sup>nd</sup> Quarter Data Summary

Hope Bible Fellowship-\$4,933.99 used to replace failing air conditioner. Due to decrease in donations, would have been unable replace it without ARPA funds. \$583.99 expenses for employee retreat for continued training.

Goodfellows of Lee County-\$6,054.43 used for improvements & accessibility to new location. Goodfellows had to relocate to a new location due to COVID and needed to make accessibility improvements to serve volunteers and clients. Remaining funds to be used on food vouchers for clients in the next quarters.

#### Community Service Program 2nd Quarter Data Summary

Shining Star Children's Advocacy Center-\$349.17 for lease of copier/scanner/fax which allows scan/fax of documents allowing no-contact exchange for documents. Funding previously used to cover this expense have been unavailable since COVID.

Meals on Wheels of Dixon-provided food assistance to 180 clients totaling \$1,916.00 and \$388.76 in assistance to the Agency for phone bill, stamps, postage and insurance.

Sinnissippi Centers, Inc.-Rent/Mortgage Assistance to clients totaling \$620 and utility assistance for clients totaling \$751.08.

Awarded 49 Small Businesses for \$10,404 each to be used for impacts of COVID.

Two businesses requested less than the allocated amount and their full request was awarded at \$5,000 and \$6,000.
