

# **Executive Committee Meeting Minutes**

I. Call to Order

III. Public Attendees

Attorney Courtney Kennedy was present in person on behalf of One Energy Development LLC. She explained that in October of 2022 the company appeared before the Zoning Board of Appeals petitioning to construct a 4-megawatt community solar project in Franklin Grove Township. The ZBA unanimously voted to recommend the project which will be on the November 22, 2022, County Board agenda. She was present to answer any questions the committee might have.

Attorney Robert LaSage attended the meeting to answer any questions that the committee might have regarding the Reagan Mass Transit District items on the agenda.

A. City of Dixon Intergovernmental Agreement for Police Dispatching

There was a lengthy discussion regarding the City of Dixon Intergovernmental Agreement for Police Dispatching. Bob Olson explained that the current Intergovernmental Agreement for Police Dispatching between the City of Dixon and the County expired in April of 2022. Bob worked with Sheriff Simonton and the City of Dixon to extend the agreement for the next six (6) years. There were two major changes to the agreement. There was an increase in the base fee to better align and share the costs of dispatch center operations between the City and the County. Also, going forward any increase in employment expenses (salary and benefits) would be split evenly between the two parties. The committee also discussed a grant opportunity that would be coming through committee in December. The City of Dixon and Mainstreet would partner with the County to modernize and reinvent the County Tourism platform. The City of Dixon and the County would both need to put up \$50,000.
