## STAFF REPORT

The Zoning Board of Appeals completed hearings on three community solar petitions this month. Petition 22-P-1597 is proposing a 4-megawatt solar development of up to fifty (50) acres along Reynolds Road in Franklin Grove Township. Petition 22-P-1598 and 22-P-1599 are a co-located community solar development that proposes to construct a 2-megawatt array on approximately 37.6 acres of land in South Dixon Township. Recommendations for approval on the three petitions will be set on the November County Board agenda for vote. The Zoning Board of Appeals also heard Lee County's submitted Petition 22-P-1602 for map amendments on seventeen parcels in Alto Township. These parcels were identified in the 2010 Lee County Comprehensive Land Use Plan as a key strategic economic development corridor, due to their proximity to the Rochelle Industrial Park. The Lee County Board designated this area in 2015 as part of the Lee-Ogle Enterprise Zone with the goal of creating jobs and promoting economic development. Part of the process to make this area attractive to perspective developers is to have the land zoned for Industrial development. The Lee County Zoning Office is petitioning the County to amend the Ag-1 Rural/Agricultural zoning on these parcels to I-3 Heavy Industrial. Receiving recommendation from the ZBA, this petition will also be voted on at the November County Board meeting.
