Tabletop Gaming Club Constitution

Article 1: Name and Purpose of Club

Section 1: Name

The Tabletop Gaming Club of Iowa Central Community College

Section 2: Purpose and Mission

We look to create a sense of community, provide a safe environment where students can come and take a break from schoolwork, have fun meeting new people, and to play tabletop games. Allowing students to relax and have fun while creating and growing a community of likeminded people.

Article 2: Membership

Section 1: Eligibility

We are open to all who are willing to be active in our community of gamers at lowa Central Community College. Current students may be listed as official member while former students and members of the broader community may be considered unofficial members.

Section 2: Membership Criteria

A student becomes a member of the Tabletop Gaming Club by attending one or multiple weekly meetings. Members are encouraged to attend meetings when it is convenient for them and are not required to attend when they are not. All members may become leaders in the club through democratic vote or luck of the roll.*

*If no one volunteers for an officer position, all those willing to be added to the "pot" will be subject to random selection by dice rolls. This is a voluntary service and will be verified with the chosen individual to obtain their approval.

Section 3: Removal of Members

The removal of members will happen if said person or people are disrespectful within or outside of the club. Such disrespectful behavior includes anything that hurts, threatens, or scares another member, student, or faculty here at lowa Central or damages/defaces personal or school property. Such disrespectful behavior shall be reviewed by the rest of the group and further actions may be taken if deemed necessary. We do not want to kick people out, but we also want this environment to be a safe one. So, if necessary, we will take action. These regulations also extend to the treatment of people and property beyond the club and campus.

Article 3: Officers

Article 4: Meetings

Section 1: Regular Meetings and Club Activities

Club meetings will occur on a weekly basis whenever possible. Members can join the club's Discord channel and/or other social media (if applicable) to be reminded of said meetings and be part of the club's online presence outside meetings as well.

Article 5: Finances

Usage of funds may be used to purchase new or replace games, to purchase food and/or drinks for meetings and activities, to purchase game-related supplies, to purchase promotional materials and items, and/or to purchase supplies and services for club activities.

Article 6: Amendments/Rules

Amendment 1: The Group is King

The group consensus supersedes decisions by officers if contention is encountered. Only the faculty sponsor, in the spirit of fairness, safety, group benefit, or college regulations, may make uncontested decisions, rules, or guidelines.

Amendment 2: Rule of 3

A minimum of three, maximum of six officers must be maintained, whenever possible, to alleviate voting deadlocks and to provide representation while members are unable to attend.

Amendment 3: Adoption of new rules or regulations

New rules, regulations, or policies shall be considered by and voted on by the active members* of the Tabletop Gaming Club. In order for a vote to be passed, 75% approval among active club members is required. The faculty sponsor, however, has final approval or veto.

*An active member is defined herein as anyone who attends meetings in a yearly cycle and/or anyone the group deems "active" for other merits.

Amendment 3: College Policies and Standards

ICCC Policies and Standards shall be followed by all members while representing the club and the college regardless whether the member is on campus or off. Repeated violations of college policies will result in the ejection of club member/s from the Tabletop Gaming Club and may require reporting to the college for disciplinary measures.
