

CHARTER SCHOOL CONTRACT MODIFICATION

THIS AGREEMENT is made effective ~~January 17, 2023~~ January 16, 2024, between **THE SCHOOL BOARD OF OKALOOSA COUNTY, FLORIDA** (the “Sponsor”), and **THE GOVERNING BOARD OF THE COLLEGIATE HIGH SCHOOL AT NORTHWEST FLORIDA STATE COLLEGE f/k/a OKALOOSA-WALTON COLLEGE f/k/a OKALOOSA-WALTON COMMUNITY COLLEGE**, a

charter school organized under the laws of the State of Florida (the “School”).

WHEREAS, the Sponsor entered the Charter School Contract with the School on July 10, 2000, granting the School the authority to establish and operate a charter school within the Okaloosa County School District for a term of five years;

WHEREAS, the Sponsor extended the School’s authorization for a term of seven years commencing on April 8, 2004, and subsequently extended the School’s authorization for a term of fifteen years, commencing on July 1, 2012, and terminating on June 30, 2027;

~~**WHEREAS**, the Sponsor and School amended the Charter School Contract on January 18, 2022, for the School to expand its capacity to 335 seats for Academic Year 2022-2023, introducing a 9th grade; and~~

WHEREAS, because the School is a high-performing charter school as defined by Florida Statutes § 1002.331, the School is authorized to expand its enrollment ~~to continue serving 9th grade for~~ students as they enter and progress through the School.

NOW THEREFORE, for and in consideration of the mutual covenants in this Agreement, the parties agree as follows:

1. The School notified the Sponsor on or before March 1, 202~~3~~4, of its intention to expand to ~~serve the 9th grade in the A.A. pathway and 10th grade in the A.S. pathway and~~ increase the School’s enrollment accordingly.
2. The School will continue to enroll students in the 9th, 10th, 11th, and 12th grades for Academic Year 202~~3~~4-202~~4~~5.
3. The School will increase its enrollment by no more than ~~10~~50 students, bringing its maximum enrollment to ~~4~~385 students per academic year, which its facilities can accommodate.
4. Except as expressly modified in this Agreement, the ~~term~~terms, and conditions of the July 10, 2000 Charter Contract and its subsequent extensions and amendments shall remain unchanged and in full force and effect.

IN WITNESS OF THE FOREGOING, the parties have executed this Charter School Contract Modification to be effective as of ~~January 17~~ November 28, 2023.
