 Rocky Mountain Engineering has completed the surveying of the land; confirmed with the District that nothing needs to be reported or run through them; currently working with the Town of Erie regarding drainage requirements; Soil reports were conducted and no special covering is required. We will have to pull permits from the State and concept designs will come next.

 The process is moving slower than expected. A meeting has been scheduled with TES and Choice Advisors (financial advisors) to discuss the Proforma that was conducted in the fall (a 5 year budgeting plan to see if purchasing a building for expansion is viable) and to determine next steps.
