**Re: *Ground Lease dated June 27, 2008***

Gentlemen:

As you know, MRH Executive Hangars, LLC and the Beaufort-Morehead City Airport Authority are parties to that certain Lease dated June 27, 2008, the term of which was recently extended by our exchange of letters, with yours dated December 4, 2020, and our renewal letter dated December 21, 2020 (the "Lease").

We recently finalized the discussions with Hubert G. Tolson III and his limited liability company, Kinston IOTC, LLC, pursuant to which we will transfer and assign our rights and obligations, as Lessee under the Lease, to Kinston IOTC, LLC, as Assignee, and the Assignee will assume all of Lessee's obligations under the Lease. The assignment and assumption of the Lease will be subject to, of course, the terms and provisions of the Lease with the Airport Authority, as well as the rights of other current users of portions of the Hangar.

Effective upon the completion of the assignment and assumption of the Lease to Kinston IOTC, Hubert G. Tolson III, as Manager of Kinston IOTC, LLC, would become the manager of Lessee's business. Therefore, pursuant to Section 11 of the Lease, we hereby respectfully request the Airport Authority's consent to the assignment of the Lease to Kinston IOTC, LLC, with the Assignee becoming the Lessee under the Lease and Hubert G. Tolson III becoming the manager of Lessee's business at that time. Kinston IOTC, LLC will thereafter be liable for performance of Lessee's obligations under the Lease for the remainder of the term of the Lease.

We request your consent to the assignment of the Lease and change of Lessee's Manager.

Please acknowledge the Airport Authority's consent to the assignment of the Lease to Kinston IOTC, LLC and the change of Lessee's Manager as herein described by signing in the space provided below and returning this letter to us.
