I. Call to Order

Meeting was called to order at 11:00 a.m., by Chair Bob Olson.

A. MOU - Lee County Tourism

Wendy Ryerson explained that the Lee County Tourism MOU was an agreement between Lee County Tourism and the Lee County Board that spells out the process in place for the next six (6) months and the steps necessary to transition the tourism program from Lee County Tourism back to the County. The County is currently in discussions with Discover Dixon to contract with them for tourism promotion.

Tom Kitson also reported that he and Wendy Ryerson had met with individuals from the Lee County Food Pantry regarding the future of the building they are currently using on West 4th. Street. They were assured that the County had no plans to evict them, but that together they would be working to find a new, safer location.

B. Review of State Statute 55 ILCS 5/5-12001.1 - Telecommunication Towers - No action required

In light of the potential cell phone tower installation in Amboy, Alice Henkel provided the committee with a handout breaking down State Statute 55 ILCS 5/5 - 12001.1.

C. Contract with Chastain & Associates

Alice Henkel explained that the ordinances governing the commercial wind and solar energy projects in Lee County allowed for the engagement of a third-party engineer for project oversite at the expense of the developer/applicant. Chastain & Associates has prepared such a contract for the County's consideration for the oversight of the GSG project at an engineering level. While this contract does not require County Board approval, it is being presented to the committee for transparency and Board Member comment.
