What is the purpose of this contract and why is it needed? The purpose and benefit of this membership is to keep up to date with the Broward County Law Enforcement Agencies that serve as our clients. As members, both the Dean of the Institute and Associate Dean of the Criminal Justice Academies can communicate directly with the Broward County Police Chiefs and the Sheriff to determine the best course of action regarding Institute training and discuss any topics brought forth by the Florida Department of Law Enforcement and the Criminal Justice Standards and Training Commission.

What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2-6.34 was used, where there are no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. Membership dues, per the Florida Statute 119.01(3) requires that all financial, business and membership records held by the organization in relation to the individual(s) or organization(s) for whom a purchase order is being issued are to be considered public records and shall be subject to the provisions of Florida Statute 119.07.

What fund, cost center and line item(s) were used? FD100, CC 0090 and business line (GLC) 64500.
