

# **County Services Committee Minutes**

# I. <u>Call to Order</u> Meeting was called to order at 9:00 a.m., by Chair Jack Skrogstad

# II. <u>Committee Member Roll Call: Chair Jack Skrogstad, Vice Chair Danielle Allen, Katie</u> White, Ron Gascoigne, Reed Akre

Danielle Allen was absent. Jack Skrogstad, Katie White, Ron Gascoigne, and Reed Akre all attended in person.

Also present: Dave Anderson (County Engineer/Highway Department), Jennifer Boyd (Assessor), Dee Duffy (Zoning Administrator), Sami Elarifi (GIS Coordinator), Paul Gorski (IT Administrator), Alice Henkel (Renewable Energy Coordinator), Jonathan Henrikson (IT Technician), Nancy Peterson (County Clerk and Recorder), and Becky Brenner (Board Secretary) all attended in person.

# III. Public Attendees

Courtney Kennedy (local council for Eldena Solar LLC) and Amber Miller (Eldena Solar LLC) attended the meeting to walk the committee through the Eldena Solar Request for an Extension for Special Use Permit item under new business on the agenda.

Caitlyn Culbertson (Representative of Amboy IL Solar 1 LLC) attended the meeting via Zoom video conferencing to refute statements and claims made by an individual that was allowed to speak at the May 25, 2023, County Board Meeting regarding a pending special use permit for the Amboy IL Solar 1 LLC solar energy system project. She explained that the statements and claims were made outside of the ZBA hearing process and according to Caitlyn included inaccuracies and misstatements. Caitlyn referenced the information presented to the ZBA during the hearing and cited the misrepresentations made by the individual. She asked that the information presented by the individual during the May Board Meeting not be considered by the Board when voting on the application during the June 22, County Board Meeting.

Alice Henkel spoke following the presentation by Caitlyn Culbertson with follow up clarification on the statement and claims made by the individual during the May 25, 2023.

# IV. <u>Approval of the Minutes from the Previous Meeting - (May 15, 2023)</u> Minutes from the May 15, 2023, County Services Committee Meeting were approved as presented without modification.

- V. <u>Transportation/Solid Waste</u>
  - A. Highway Report

# 1. Resolution: Intergovernmental Agreement Between South Dixon Township and Lee County

Dave Anderson explained that the Intergovernmental Agreement Between South Dixon Township and Lee County was still being reviewed by the State's Attorney's Office and would not be presented until the July meeting.

<u>Motion</u> to table the Intergovernmental Agreement Between South Dixon Township and Lee County Regarding the Use of a Salt Storage Shed located on South Dixon Township Property. <u>Moved</u> by Reed Akre. <u>Second</u> by Ron Gascoigne. <u>Motion</u> passed unanimously by voice vote.

#### 2. Resolution: Salary of the County Engineer

Dave Anderson presented a Motor Fuel Tax Fund Appropriation Resolution for the County Engineer's salary. In accordance with his appointment agreement, Dave receives 96.55% of the state recommended salary. This complies with the State program that allows the County to transfer one half of the County Engineer's salary from Federal Funds to the Department's Motor Fuel Tax Fund.

<u>Motion</u> to move the County Engineer Salary Resolution to the Executive Committee for inclusion on the June County Board agenda. <u>Moved</u> by Katie White. <u>Second</u> by Ron Gascoigne. <u>Motion</u> passed unanimously by voice vote.

#### 3. GSG Repower Road Use Agreement

Dave Anderson explained that the GSG Repower Road Use Agreement is a fairly standardized agreement that includes the same basic language and concepts that have been used in the past. Road names and dollar amounts are revised to reflect the scope of the specific project. Within the road use agreement as an exhibit is an escrow agreement.

<u>Motion</u> to move the GSB Repower Road Use Agreement to the Executive Committee for inclusion on the June County Board agenda. <u>Moved</u> by Ron Gascoigne. <u>Second</u> by Reed Akre. <u>Motion</u> passed unanimously by voice vote.

#### 4. GSG Re-Power Escrow Agreement

Dave Anderson explained that within the road use agreement, as an exhibit, was an escrow agreement that is required to be adopted separately. The County requires a letter of credit to collateralize the project in the event that the corporation would cease to exist. However, in this case, Wells Fargo would not agree to a letter of credit, so the developer agreed to put up \$50,000 in an escrow account to cover any legal fees necessary to pursue a letter of credit draw should it be denied.

<u>Motion</u> to move the GSG Re-Power Escrow Agreement to the Executive Committee for inclusion on the June County Board agenda. <u>Moved</u> by Katie White. <u>Second</u> by Reed Akre. <u>Motion</u> passed unanimously by voice vote.

# VI. Assessor's Office - GIS Department

- A. Assessor's Office
  - Jennifer Boyd reported the following information from the Assessor's Office:
    - The office has been very busy with tax bill and assessment questions.
    - The office continues to work on the 2023 task lists.
    - The required Board of Review Organizational Meeting and the Farmland Assessment Review Committee Meeting have been scheduled.
    - At the Board of Review Organizational Meeting the new Chairman will be elected, and the rules will be approved.
    - The Farmland Assessment Committee will review the Farmland assessed values for 2024.
- B. GIS Department
  - Sami Elarifi reported the following information from the GIS Department:
    - Sami and Logan Griswold (summer intern) worked with the City of Dixon to get the traffic signals, streetlights, and airfield lights added to their web map. The City of Dixon water Department provided the GIS Department with blueprints and as built drawings to complete the task.
    - Logan is working on updating the Zoning map and a wall map for Lee County Fire Districts.
    - Sami continues to update the 911Flex map and the monthly parcel data maintenance and land use for the County maps.
    - GIS data and map request have been submitted for the Village of Paw Paw and Franklin Grove. Parcel data shape files and a list of multi-family dwellings in Lee County were submitted for the Lee Ogle Enterprise Zone and the City of Dixon parcel lines requested by an engineering service were submitted.
    - Sami thanked IT Director Paul Gorski for providing the Department with the .gov certificate for the new GIS server. The certificate will initiate secure connection and establish trust between the new GIS server and clients and will allow the department to build a new and clean web map and GIS enterprise.

Following his internship, he will be attending the University of Platteville-Wisconsin to study cybersecurity.

B. Revised Title VI Plan

Greg Gates also walked the committee through the Revised Title VI Plan item on the agenda. He explained that LOTS is required to revise the Title VI Plan based on feedback from IDOT on potential language changes coming down from the Federal and State Government. Following a compliance audit in November of 2022, IDOT requested that revisions be made. One of the major changes was inclusion of statistics geared toward English limited proficiency individuals.

 A. Eldena Solar - Request for an Extension for Special Use Permit Issued September 17, 2020

Courtney Kennedy and Amber Miller walked the committee through the request for an extension for a Special Use Permit that was issued to Eldena

Solar on September 17, 2020. Courtney updated the committee on the progress that has already been made on the project and explained that continued progress has been substantially hindered by delays on the part of ComEd and PJM regarding required facility studies. She also cited continued employment issues and supply chain shortages due to COVID 19. A three-year extension was requested.

- C. Flag Flying and Display Policy for Lee County Consideration
  - 1. Resolution: Flag Flying and Display Policy for Lee County Consideration Angie Shippert walked the committee through the Flag Flying and Display resolution on the agenda. As the resolutions spells out: "County flagpoles are not intended to serve as a public forum for private expression by the public. Flags that the County displays on County flagpoles constitute government speech by the County and that any flags flown on County flagpoles are an expression of Lee County government's official sentiment and represent Lee County's support of what those flags represent". Ceremonial flags may only be displayed with the approval of the County Board by a 2/3 majority.

<u>Motion</u> to move the Flag Flying and Display Policy for Lee County to the Executive Committee for inclusion on the June County Board agenda. <u>Moved</u> by Ron Gascoigne. <u>Second</u> by Reed Akre. <u>Motion</u> passed. unanimously by voice vote.
