Opportunity Scholarship FAFSA Requirement Adjustment

Pursuant to <u>Utah Code 53B-8-201(5)(c)(ii)</u>, and Board Policy <u>R608</u>, applicants for the Opportunity Scholarship are required to "complete and submit either the Free Application for Federal Student Aid (FAFSA) or the alternative financial form approved by the Board." Though the Opportunity Scholarship is a merit-based scholarship that does not rely on an applicant's financial need, the Legislature and the Board require the completion of this application as a mechanism to help students access other state and federal aid.

Given ongoing challenges with the federal Department of Education's ("department") deployment of the new 2024/25 FAFSA—including the delayed application availability until December 31, 2023, and the ongoing application problems that have limited students' ability to complete the new FAFSA—students in the 2024 Opportunity Scholarship application cycle may not be able to complete a FAFSA for reasons beyond their control. Additionally, based on the department's recent announcement that the institutional student information records (ISIR) will not be available until March 2024 at the earliest, the Commissioner's Office may not be able to audit and verify an applicant's FAFSA completion.


The Commissioner's Office recognizes the value in the completion of a FAFSA and continues to encourage all high school seniors to complete this application that grants access to federal and additional state financial aid. The Commissioner's Office even delayed the 2024/25 scholarship application window until the spring to accommodate the department's delays in the availability of the 2024/25 FAFSA. However, due to the ongoing complications and uncertainty of the department's implementation of the new FAFSA, the Commissioner recommends that the Board adjust the FAFSA completion requirement for the 2024/25 cohort, as outlined in the Commissioner's recommendation.

UTAH SYSTEM OF HIGHER EDUCATION

Commissioner's Recommendation

For the 2024 Opportunity Scholarship application cycle, the Commissioner recommends that the Board accept a student's written commitment to complete a 2024/25 FAFSA, where reasonably practical, prior to the beginning of the fall 2024 semester as qualifying eligibility documentation in lieu of 2024/25 FAFSA completion.
