



- Two (2) investigations concluded prior to live hearing/determination
  - One resignation of respondent
  - One Pre-Determination Resolution (agreement between student parties)
- Two (2) conducted live hearings and issued determination notice
  - One finding of responsibility for university policy violation
  - One no finding of responsibility
  - Both in appeal phase
- Three (3) currently in investigation phase
  - 2 in finalization of investigation report to be distributed to parties and Determination Official
  - 1 evidence collection and interviews with parties and witnesses ongoing

- Statement of Economic Interest Filing Deadline
  - 32 employees outstanding as of 1/26/2024
  - Personal fine of \$250 for failing to file by February 1 deadline
  - 57 employees pending completion of biennial training as of 1/22/2024
