#### Pavchex 401K discussion

- Paychex is the #1 keeper for 401Ks
- Everything is handled through the Paychex Flex System employees can make changes per pay period.
- All notifications and rollovers are handled by them.
- Setup with Paychex specialist (3-4 weeks)
- Employee Contribution: 1%-92% of paycheck. (Max \$22,500/year/employee)
- Employer Match 1:1 up to 3%, 0.5:1 up to 4% (Max Employee \$5/Employer \$4)
- LOWERS PAYROLL TAX LIABILITY
- \$2000 startup (paid over 24 months)
- \$105 monthly + \$5/employee (under 4 employees)
