**A RESOLUTION CERTIFYING PAST-DUE INVOICES  
TO VARIOUS COUNTY AUDITORS  
FOR COLLECTION WITH THE 2024 PROPERTY TAXES**

**WHEREAS**, the City of Princeton has incurred costs on the behalf of services provided to City of Princeton Residents, and

**WHEREAS**, the Princeton Fire and Rescue Department is responsible for responding to structure fires, medical calls and accidents within its service territory, and

**WHEREAS**, the City of Princeton has established fees for the provision of services by the Princeton Fire and Rescue Department, and

**WHEREAS**, the Princeton Fire and Rescue Department prepares and the City issues an invoice for services rendered, and

**WHEREAS**, the recipients of the services rendered have received the original invoice, a second invoice and a letter requesting payment, and

**WHEREAS**, there are outstanding unpaid invoices for fire calls; and

**WHEREAS**, the City of Princeton adopted Ordinance 818 whose Section 5 provides for the certification of unpaid amounts to the county auditor in which the recipient owns real property for collection with property taxes.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Princeton, Minnesota, does certify for collection by the appropriate County Auditor the unpaid past due amounts for invoices and services rendered by the Princeton Fire and Rescue Department as noted on Exhibit A. Further, that said amounts shall be collected with the 2024 property taxes levied against said parcels.
