

### Recap of the 2023 legislative session


- Budget Surplus of \$17.5 billion
- Session began on January 3/ended on May 21
- Historic Investments





### What to expect in 2024

- Session begins on Feb 12/ends on May 20
- \$240 million surplus
- "Structural imbalance"
- Bonding Bill:
  - \$830 million in GO Bonds / \$152 million asset preservation
- Policy focused
- Legislative breaks for observances:
  - Easter Recess: Mar 27 Apr2
  - Eid Recess: Apr 9 Apr 11
  - Passover Recess: Apr 22 Apr 24

# **Emergency Medical Services (EMS)**

- Pressing issue statewide
- Long-term solutions needed
- League convening EMS Delivery and Sustainability Task Force
- Monitoring work of Legislative EMS Task Force
- Supporting bill to address urgent funding needs
- Working with other city groups



# School Resource Officers (SRO's)

- Issue stems from legislation enacted in 2023 (omnibus education bill)
- Required two attorney general opinions
- League supports clarifying what authority school resource officers have to intervene when a law is broken in school setting
- Involved in meetings and negotiations
- Quick action possible, but not guaranteed

# **Public Safety Duty Disability**

- Closely tracking implementation of 2023 law
- Reluctance to reopen due to litigation and relative lack of new information
- Aware of some emerging and ongoing problems
- Need permanent funding for provisions (likely a 2025 issue)

# Local Government Aid

- 2023 omnibus tax bill enacted \$80 million increase in Local Government Aid and formula changes
- Last year's tax bill also included \$300 million in one time public safety aid, \$210 million went directly to cities
- House and Senate tax committees both interested in hearing from cities on Public Safety Aid and the impact it had across the state



# **Local Sales Taxes**

- Two year moratorium on consideration of local sales taxes by the legislature in place through 2025
- Local tax advisory task force report released February 2nd
- Task force recommendations include limited general authority for certain types of projects, focus on regionality
- Both tax committees will hear the report and it will be a topic of discussion in a non-budget year



# Sales Tax Exemption on Construction Materials

- In 2023 the Governor's budget recommendations and the House omnibus tax bill included the general exemption from sales tax on construction materials on a temporary basis
- The final bill did not include the exemption, instead opting to provide city specific exemptions instead
- Broad buy in around this issue, but limited funds make it difficult to get across the finish line

## **Housing – Resources**

- Limited surplus means lowered expectations on general fund spending and a focus on capital investment resources for housing
  - Housing Infrastructure Bonds (\$50M in Gov. Bonding rec.)
  - General Obligation Bonds for Public Housing (\$7.5M in Gov. Bonding rec.)
- Addressing housing through tax policy
  - Bills to broaden Tax Increment Financing (TIF) use for housing
  - Unobligated TIF transfer to Local Housing Trust Fund authority expansion
  - C/I property conversion to residential tools include tax credit, TIF, general fund program

# **Housing - Policy**

- Coming off \$1B Housing Bill = laser focus on policy this session
  - HF 685/SF 365 Renewed conversation on prohibition on corporate/investor purchases of homes for single-family rental.
  - Source of Income Protection for renters
  - HF 1402/SF 1146 Authorization for cities to impose impact fees

### Zoning and Land Use Preemption

- Parking Over People Act prohibits parking minimums for all development
- Missing Middle Housing Legislation increased density by-right
- Continued discussions on material design standards, ADUs, minimum lot sizes etc.

## Zoning Preemption – "Legalizing Affordable Housing Act"

### HF 2235 (Elkins) includes some concerning provisions:

- Requiring housing proposal contemplated by a comprehensive plan in the future be accepted now, even if needed infrastructure isn't available to support it
- Capping land dedication and park dedication fees
- Requiring land dedication for streets to be no larger than 32 feet, while limiting ability to require adequate off-street parking

### • Provisions to be broken out into standalone bills:

- Requiring all cities to allow duplexes and accessory dwelling units (ADUs) in single-family zoned areas
- Prohibition on material design standards
- Limitations on Planned Unit Development use
- Prohibition on minimum square footage and requirements for more than one garage stall in new single-family homes


# **Environmental Policies**

- PFAS drinking water, municipal liability, biosolids, testing, funding.
- Nitrates tax on ag fertilizer.
- Solid Waste packaging, bottle bill, recycling
- Environmental Review



# Bonding

- \$830 million debt capacity
- Governor's proposed capital budget \$982.5 million
- \$819.4 mill. GO bonds, rest user-financed, appropriation, trunk highway
- Final package could include additional general fund appropriations.

# **Employment Issues**

Earned Sick and Safe time implementation:

- Law went into effect on Jan. 1
- Challenges in applying new law to paid on-call/volunteer firefighters and ambulance personnel.
- Bill to exempt those positions from the law and clarification for elected officials and board/commission members.

Potential Paid Family and Medical Leave revisions, other labor and employment proposals.



# **Adult-Use Cannabis**

- Initial Office of Cannabis Management report to the Legislature indicated several proposed changes in the law.
- Reordering of the licensure process and creation of temporary licenses to advance social equity goals.
  - Local government zoning approval process would be moved towards the end of the process.
  - Quicker timeline for OCM to absorb Office of Medical Cannabis to aid in inspections and enforcement.
- OCM convening meetings with local governments to work on model ordinance requirement.

#### Bottom Line

A zoning preemption bill will be heard on **Tuesday, March 9, at 1:00 pm** in the Senate Housing Finance and Policy Committee. Cities know their communities and are in the best position to address local zoning – not the state legislature.

#### Background

SF 915 (Sen. Rich Draheim, R-Madison Lake) would preempt local zoning authority by limiting planned unit development (PUD) conditions, prohibiting aesthetic conditions, mandating allowance of temporary family health care dwellings, requiring a 60-day rule for building permits, etc.

#### We need your help!

Contact your Senator on the Senate Housing Finance and Policy Committee with your concerns with SF 915.

#### Key Points to Include in Your Letter/Email:

- Cities know their communities and are in the best position to address local zoning and respond to local needs – not the state legislature. This one-size-fits-all bill attacks the fundamental importance of local control and treats every city in the state the exact same regardless of locally identified needs.
- SF 915 would preempt decisions that cities make to guide land use. Universally
