- Sophia has been hearing from industry groups about the need to connect programs and certifications with in-demand institutions. She is learning that there is a need for quick turn-around programs. Example given: long haul truckers. We shared with Sophia that we will work with her to connect her with Larry Lundblad and Mary Rothchild to ensure connections are made between campuses and industry.
