A. School Goals (Presenters: Dawn Klaiber)

The integrated action plan is required when accepting federal funds through the ESEA grants program. The process was greatly simplified for Arizona LEAs for the upcoming grant cycle. All schools were asked to reflect on the following guiding questions and rate their progress according to a rubric with the scale of: 0- Not Yet Begun, 1- Beginning Implementation, 2-Beyond Initial Implementation, 3- Deeply Embedded.

Our Process: As the new IAP directions were rolled out, I participated in a training webinar, and collaborated with Nancy Alexander to better understand the new process. Nancy and I then led a work time with the leadership team to analyze data points and assess our school using the guiding questions rubric. Based off these results we developed draft goals. I then led a session with the teaching staff on a Friday similar to what the leadership team had done in order to gather input from staff members. The leadership team helped guide small groups through the questions on the rubric followed by discussion. This input led to another work/planning time with the staff, leadership team, and Nancy as well as updated action steps within our IAP. The board and public are now welcome to contribute ideas and desired outcomes to what the staff has developed.

Our IAP will be submitted along with our FY25 ESEA grants in the next week. This is a fluid and working document that intends to provide direction and support to schools. It can be updated and/or amended throughout the year as action steps are met or new action steps are needed.
