In sum, Chair Angier stated for the record that the North Broward Hospital District would approve Resolution FY22-05 and adopt a millage rate. The roll-back rate for fiscal year 2022 was 1.0982 mills. The proposed millage rate to be levied was 1.2770 mills. The percentage increase over the roll-back rate was 16.28%.
