Parcel 1: Part of the West half (W1/2) of the Northwest quarter (NW 1/4) of section (13), township twenty-one (21) north, range nine (9) East of the fourth Principal Meridian, Lee County Illinois, described as follows:

Beginning at the centerline of McGirr Rd which borders the Northerly Boarder of the property line travel south 1350'Ft parallel with Red Brick Rd to starting point; thence easterly 600 feet; Thence Southerly 900 feet parallel with the Westerly boundary; Thence Westerly 600 feet parallel with Northern boarder to the center line of Red Brick Road; Thence Northerly 900 feet parallel with Red Brick Road to the northerly starting point.
