TOPIC: 2022 Legislative Session Report

EXPLANATION:

On January 12, 2022, Colorado's 73rd General Assembly reconvened for their second regular legislative session. With the General Assembly no longer under Joint Rule 44, the clock has started and will run for 120 consecutive days and conclude on Wednesday, May 11th.

In January, Chancellor Garcia testified before the Joint Budget Committee on behalf of the System to advocate for funding and priority projects. Pikes Peak Community College President, Dr. Bolton, testified before the Joint Business Committee as part of the SMART Act hearings along with several other higher education institutions who receive state funding for cyber projects per Senate Bill 18-086.

On February 3, the Joint Technology Committee discussed prioritization of FY-23 IT capital requests. CCCS's "Rural College Consortium for IT Infrastructure" was prioritized and recommended for full funding (\$8.6M). The project will benefit six rural colleges, CNCC, LCC, MCC, NJC, OC, and TSC, in modernizing their technology infrastructure and allowing those colleges to link through technology to share instruction and student support services.

On February 10, the Capital Development Committee is scheduled to discuss prioritization of FY-23 capital construction requests. The annual prioritization of capital projects by the Office of State Planning and Budgeting (OPSB), in December of 2021, yielded recommendations for funding three CCCS projects, listed below, and funding for all three levels of controlled maintenance.

Update on CCCS-initiated bills:

LPN-to-BSN Bridge Program

CCCS seeks to amend its role and mission statute to allow interested colleges the option to offer a LPN-to-BSN bridge program. The intent of the legislation is to offer a pathway for licensed practical nurse (LPN) students to earn a BSN.

Bill updates:

- On January 12th, the bill was introduced and assigned to Senate Education Committee.
- Bill title: SB22-003 "Community College Nursing Bachelor Degree Eligibility"
- Prime Sponsors: Senator Janet Bucker and Kerry Donovan, Representatives Kyle Mullica and Tony Exum
- SB22-003 is scheduled for Senate Education Committee on Wednesday, February 9th upon adjournment

Pikes Peak Community College Name Change

CCCS seeks to change the name of Pikes Peak Community College to "Pikes Peak State College." This effort is being led by PPCC leadership and has tremendous support from their campus and local community. The intent of the legislation is to support PPCC's efforts to modernize their name and increase their value-perception among students and employers, and to effectively market the institution to help foster enrollment growth, build partnerships, and increase overall competitiveness in the Colorado Springs region. The proposed legislation would not change PPCC's role and mission.

Bill updates:

- Received approval from Legislative Leadership to be introduced as a late bill.
- Prime Sponsor: Representative Marc Snyder.
- Bill is in draft and expected to be introduced in late February.

CCCS lobbyists will give the Board a brief summary of happenings under the dome and provide insight on bills and initiatives on the horizon affecting higher education.
