Supplemental Narrative for
Section 4: Details of Project/Expenditure.**

Type Size and Location of the culvert to be replaced.

The proposed project consists of replacing a 5'-6"x9'-3" double barrel cast in place reinforced concrete box culvert that carries Brooklyn Road over a small stream just north of the intersection of Water Street in the Village of West Brooklyn. Brooklyn Road is under the Jurisdiction of Lee County.

Justification for culvert replacement

It is imperative the culvert be replaced for the following reasons:

1. The structure has aged to a point that structural integrity is of primary concern. A significant portion of the concrete in the culvert bottom has eroded away leaving this element of the culvert less able to resist buoyant forces from below which in turn stress the components of the culvert that are expected to carry the traffic loads.
2. After performing a hydraulic modeling analysis, it has been determined that the existing culvert is actually undersized and will not carry an adequate amount of storm water during a 100 year storm event. This can lead to upstream flooding and leave the surface storm water controls overwhelmed.

The subsequent photos indicate the typical condition of the culvert:



Bottom slab eroded



1" crack in bottom of top slab



Pipe carrying storm water has failed, allowing rock and sediment to filter in, creating a void in the roadway above.



1/4" - 1/2" crack in back wall (typical)

Project Conformity to ARPA eligibility guidelines:

Since the primary purpose of this County owned culvert is to carry a small stream and its associated storm water, including storm water from the roadway surface, this project meets current ARPA eligibility requirements.

Estimate of cost and funding sources:

A detailed estimate will not be prepared until a significant portion of the engineering is complete. The preliminary estimate for both construction and engineering is \$525,000. Any ARPA funds allocated for this project would likely be paired with a mix of Rebuild Illinois Funds (State) and County Matching Funds (Local).
