Alaska Police Standard Council

Officer Ryan McMicken has successfully completed his FTO as a Police Officer for the City of St. Paul and as required by the state of Alaska. All mandatory paperwork and application will be submitted to APSC for Officer Ryan McMicken Basic Law enforcement certification.

Police

The State of Alaska is still maintaining the Covid-19 regulations for state residents to continue social distancing and the use of masks when in door public places.

St. Paul Dept. of Public Safety is assisting the St. Paul Community & St. Paul Unified Command in providing updated educational material to those traveling to St. Paul from outside the community. The 14-day quarantine is still mandatory for all traveling to St. Paul.

SPDPS has responded to 70 Covid19 related calls for service since late March 2020.

St. Paul Dept. of Public Safety has been directing more calls for services that lean towards civil infractions and community COVID-19 violation matters to be heard by the Aleut Tribal Court.

Dispatch

St. Paul Emergency Dispatchers have been training in Power Phone. Dispatchers have successfully completed the Training, all Dispatchers are certified in LED (Law Enforcement Dispatch), EMD (Emergency Medical Dispatch) and FSD (Fire Service Dispatch). Along with the EMD, dispatchers will now be able to assist callers with telephone assisted CPR. This certification is good for two years. St. Paul dispatchers will be able to assess calls effectively and consistently and improve dispatcher's ability to communicate with community members in need of emergency services.

EMS / Ambulance

As of 1/08/21 Public Safety has had a total of 125 medicals and 38 medivacs for 2020.

EMS volunteers are fully equipped with PPE to help protect against airborne virus COVID-19.

Fire Department / SAR

St. Paul Volunteer Fire Dept. personal along with Search and Rescue, EMS, SPDPS continue to complete weekly trainings.




Harbor Master

COVID CALLS REPORTED TO PUBLIC SAFETY

The colors on the dates signifies the same person.

- 3-30-20 (120) Female under quarantine went to community store, unable to locate.
- 3-31-20 (122) Same female broke quarantine was found and served with trespass papers from Community store. Public Safety reiterated quarantine rules.
- 4-02-20 (350) Same female was reported banging on a residence's door at 0140 in the morning. Female was located claimed it was not her. Female was advised by Public Safety about quarantine and other conditions.
Unfounded call.
- 4-06-20 (135) Same female was at the residence of a party who did not want her there. She was informed by Public Safety of the City Stay at Home Mandate and made to leave.
**Tribal citation was issued.*
**No more calls on this female.*
- 4-14-20 (149) Report of 2 females at a male's house who is under quarantine. Females were not at the residence upon officer's arrival, male party stated the females were not there. Male party was reminded by Public Safety of quarantine rules. Public Safety went to female's residence and spoke to them, they stated they were not at the residence. Public Safety advised them of male's quarantine and if found there they would have to quarantine as well, they understood.
Unfounded call. No more calls on this male or females.
- 5-12-20 (194) Male party who is on quarantine seen driving with another male party. Public Safety spoke with male party about quarantine rules. He stated he understood. Unknown if other male party was spoken to.
- 5-14-20 (198) Reported that a male was seen going into a residence where another male on quarantine lives. Male under quarantine was spoken to by Public Safety about rules. Male stated the other party was not inside house and is currently at clinic. The male at the clinic was left with quarantine rule paperwork and asked clinician to speak with male party as he was in appt. about the seriousness of those in quarantine.
- 5-15-20 (205) Report of male party not wearing a mask around plane, individual was spoken to by Public Safety, stated he understood.
No more calls on this male.

COVID CALLS REPORTED TO PUBLIC SAFETY

- 5-18-20 (207) Male party who is in quarantine was reported to have been driving around with 2 other individuals. The individual under quarantine stopped and came in close contact with another. Investigation found this to be true.
**Tribal Citations for all three were issued for Civil Mischief.*
**The two individuals found driving with male in quarantine where also placed on a two (2) week quarantine.*
- 5-21-20 (216) Male under quarantine has individual over drinking alcohol. Public Safety spoke to individuals about quarantine and citations were issued.
**Tribal Citation issued for Civil Mischief*
**Male placed on two (2) week quarantine.*
- 5-21-20 (219) Female called stated male party who is under quarantine is headed towards her house and she does not want him there. Male party banging on door and windows. Male party taken into our custody. Upon sober male party was spoken to by Public Safety about the quarantine rules.
No more calls on this male.
- 5-28-20 (225) Report of male party under quarantine standing with another male party outside of a residence. Upon speaking with the parties, it was found they were outside but stated they were not in proximity of each other. Cannot determine either way. Male in quarantine was reminded by Public Safety to keep distance and what the quarantine rules are.
Unfounded call.
- 5-29-20 (228) Call of female under quarantine having party, no party occurring.
Unfounded call.
- 5-31-20 (348) Male under quarantine was reported to be going to the store to buy cigarettes. He was stopped by his son before getting there. Public Safety went to his residence and he was advised of quarantine rules.
- 6-02-20 (229) Male party under quarantine tried going into store, store personal would not allow him access into store. Public Safety advised the male party about the rules of quarantine and what was allowed and not allowed.
- 6-02-20 (230) Male party under quarantine was seen giving money to another individual. Public Safety advised male party of quarantine and social distancing during this time.

COVID CALLS REPORTED TO PUBLIC SAFETY

- 6-13-20 (257) Male under quarantine was seen getting mail from the post office. Male party was spoken to by Public Safety about what he can and cannot do under quarantine. He understood.
No more calls on this male.
- 7-02-20 (303) Male under quarantine walking towards the store, have had problems in the past with him going to the store to buy cigarettes.
- 7-07-20 (316) Male under quarantine went into post office. Officer went to speak with individual and was unable to locate.
- 7-08-20 (317) Male under quarantine went into the post office again. Public Safety spoke with male party and advised him of the quarantine rules and what was allowed and not allowed. He stated he understood.
No more calls on this male.
- 7-10-20 (321) Male under quarantine was reported at a residence the night before. Public Safety spoke with male party and he was made aware of what was allowed and not allowed.
- 7-11-20 (324) Male under quarantine had UPS delivered to him. Public Safety spoke with individuals to make sure safety precautions were used.
Unfounded call.
- 7-16-20 (336) Male juvenile under quarantine spent the night at relative's residence. Parent, juvenile and relatives were explained by Public Safety what they can and cannot do during this time.
**Tribal Citation issued for three people.*
**Two relatives place on two (2) week quarantine.*
- 7-17-20 (341) Male juvenile under quarantine was trying to play with kids at another residence. Officer went and spoke to juvenile and juvenile started walking home. He was informed again what was allowed and not allowed while under quarantine.
No more calls on this male.
- 7-21-20 (343) Call of two people going to the residence of two others on quarantine. Upon investigating, all parties denied anyone entering or having entered the residence. Nobody was seen going in or exiting. Those on quarantine were informed by Public Safety of what is allowed and not allowed during quarantine.
Unfounded call.
- 7-21-20 (344) Female reported male on quarantine is walking down the street alone with mask on. Female was told that this was acceptable.
Unfounded call.

COVID CALLS REPORTED TO PUBLIC SAFETY

- 7-25-20 (347) Male and female who are on quarantine came in on flight. They were called by Public Safety and asked if they understood what is required of them being under quarantine via paperwork they received. It was explained again to them and questions they had were answered.
- 7-30-20 (354) Report of two individuals who were in close contact with several people on quarantine. Public Safety spoke with the individuals on quarantine and reminded them of what is acceptable and not acceptable during the two-week period as they are essential employees.

COVID CALLS REPORTED TO PUBLIC SAFETY

Calls from 07-30-20 until 09-15-20

- 7-31-20 (355) Report of GCI employees who are on quarantine attempting to go to the Tribal Store. L. Nutter advised they cannot enter. Public Safety made contact and advised them of what is allowed and not allowed during quarantine. Public Safety gave them the store number for food to be ordered and delivered.
- 8-06-20 (359) Report of male party on quarantine having gone to the Tribal Store. He did not go inside but was outside in parking lot area. Male party was gone from store upon officer arrival. Male party was advised by Public Safety of what is allowed and not allowed during quarantine.
- 8-12-20 (363) Anonymous report of 2 males at the house of someone under quarantine. One male party was stated to have been seen entering the residence. Public Safety attempted to locate both parties as well as the party under quarantine. Was unable to locate parties on said day. Messages were left with all parties.
No more calls on these 3 individuals.
- 8-17-20 (373) Public Safety and Harbor Master escorted several members of a boat crew from airport to harbor. Passengers were not cleared to land in Saint Paul Island as paperwork was not received in a timely manner.
- 9-03-20 (399) Major medical emergency on board F/V. EMS and Officers were in proper PPE, treated and transported patient to waiting Medivac plane.
- 9-13-20 (413) A community member reported a person who is in quarantine going to the Clinic. I advised this is not a violation of quarantine. People who are in quarantine, if a medical need, can go to the clinic if they call ahead and wear a mask. Dispatch stated they would advise the community member. I also advised Dispatch to have the community member go onto the City of Saint Paul website and review what is and is not allowed.

COVID CALLS REPORTED TO PUBLIC SAFETY

Calls from 09-15-20 until 11-12-20

- 09-28-20 (431) Complaint of person who is under quarantine going to visit people at others Residence. Was unable to prove anyone seen this occur, only word of mouth. Public Safety spoke with the party under quarantine and advised them of what is and is not allowed while under quarantine.
No more calls on this individual.
- 09-30-20 (434) Complaint of a person going to the house of someone in quarantine. The complainant seen the individual go into the house and come out within minutes. Public Safety spoke with the individual and advised this person they cannot go into residences where someone is under quarantine. The party understood.
No more calls on this individual.
- 10-01-20 (436) Complaint of individual who is under quarantine said to be visiting another residence. Public Safety spoke with individual and advised them of what is allowed and not allowed while under quarantine.
No more calls on this individual.
- 10-02-20 (438) Report of person under quarantine went into a public place. Public Safety contacted person under quarantine and advised them of what is and is not allowed under quarantine. Individual did not know and apologized.
No more calls on this individual.
- 10-04-20 (442) Public Safety was notified of an individual who is under quarantine at another's residence. Public Safety contacted the individual. Individual stated they were not at anyone's residence. Public Safety regardless advised them what is allowed and not allowed while under quarantine.
No more calls on this individual.
- 10-06-20 (449) Individual stated they seen an individual who is still under quarantine in the office space of another. Public Safety contacted the individual and advised them they are still under quarantine and what is and is not allowed during this time.
No more calls on this individual.
- 10-15-20 (467) Complaint of person on quarantine going to another's residence. The person in the residence is also under quarantine. Public Safety advised that it is not recommended that they are together but not much we can do. They went into quarantine at the same time.
No more calls on one of the individuals.
- 11-01-20 (495) Complaint of an individual inside the residence of two people who are under quarantine. 3 people were cited into Tribal Court and 1 put into quarantine due to contact.
(2nd call on two of these individuals.)

COVID CALLS REPORTED TO PUBLIC SAFETY

Calls from 11-13-20 until 12-31-20

- 11-18-21 (516) Complaint of a male individual who was under quarantine having someone over at their residence. Male party under quarantine was asked if they read the quarantine guidelines they received, stated they did. Individual who was at house was spoken to and advised about the quarantine rules and what was allowed and not allowed.
** Tribal Citation was issued to the original individual under quarantine.*
** Second individual was quarantined for 2 weeks.*
No more calls on these 2 individuals.
- 11-23-20 (523) Complaint from an individual who was at the clinic for an office visit, stated a staff member was not wearing a mask. Complaint stayed internal and was investigated as such.
Unfounded Call.
- 11-20-20 (524) Complaint of a female individual who was under quarantine having been inside a public building. Public Safety made contact and reiterated to them about what was allowed and not allowed while under quarantine. Individual stated they understood.
No more calls on this individual.
- 11-25-20 (528) Complaint of an intoxicated female individual under quarantine going to the Tribal Store to purchase cigarettes, refused to leave until purchase was made. Tribal Store employees social distanced and sold cigarettes to individual. Only after the interaction was it reported to Public Safety. Public Safety contacted individual and reiterated what is allowed and not allowed under quarantine.
** Citation was issued to individual.*
No more calls on this individual.
- 12-22-20 (567) Complaint of a male individual at the residence of two female individuals under quarantine. Public Safety spoke with all parties about the rules of quarantine and what was allowed and not allowed.
** Male party was advised he will be issued a Tribal Citation and placed under quarantine for 2 weeks.*
- 12-22-20 (568) Complaint of male individual who recently was told he would be under quarantine giving rides to people to and from bulk sales. Public Safety contacted the male individual at his residence and explained to him that he is under quarantine and is not allowed to have contact with others, give rides to other or go into any public buildings for a period of 2 weeks. He was advised if he had questions to call Public Safety.
** At this time the Tribal Citation was given to him.*
No more calls on this individual.

COVID CALLS REPORTED TO PUBLIC SAFETY

12-29-20 (579) Complaint of a female individual under quarantine at the Tribal Store. The female parties name was given to Public Safety. Public Safety viewed the quarantine list and observed there was less than 3 hours left on her quarantine. Female party was elderly and did not know there was a specific time on the date her quarantine was up. Public Safety advised the Store Manager there was less than 3 hours left on her quarantine, all parties agreed to leave it as is.

No more calls on this individual.
