SUBJECT: Update on VMSDEP Friends request for Virginia Military Institute Board of Visitors Resolution and Action on the Virginia Military Survivors & Dependents Education Program (VMSDEP).

Dear Members of the Board of Visitors:

- 1. The purpose of this letter is to thank you for the opportunity to attend the Board of Visitors (BOV) Executive session today in Richmond and update you on the status of our efforts before the full BOV takes up our proposed resolution tomorrow.
- 2. Although we welcomed the opportunity to attend, we were disappointed in our initial reception by BOV Secretary Col. Bill Wyatt's dismissive first comment that our issue "will not be dealt with today." We noted that the BOV Executive Committee made time available to "bring into the open session from the closed session" discussion of a community college program then discussed items not on the published agenda including, the student newspaper. A good amount of time also covered the BOV President's recent injury from his dogs. Unfortunately, you had no time to take on discussion of this serious veterans issue. The BOV secretary was quick to point out that the only time the public is allowed to speak is once a year in April and we missed it. Given the urgency of the resolution of this issue, we were hopeful that an exception would be made.
- 3. We are extremely grateful the Executive Committee followed the Code of Virginia, VMI BOV By-laws, Statement of Governance to modified the published BOV agenda for June 27th and add our requested resolution. Mr. Watjen's public commitment to take up our resolution in the Executive Session is most welcome and reflects positively on VMI's support to veterans and their families. We trust VMI's reputation of integrity and honor to <u>act</u> on our resolution and not just have the staff present a briefing disputing our request without our involvement or voicing general support for veterans without any <u>actionable</u> result.
- 4. Your decision to take up our resolution puts VMI in the lead for this important issue as it should be. We're happy update you that as of today 96 of 100 Members of the Virginia House of Delegates have signed <u>HB6003</u>, that calls for <u>a full repeal of the changes made to VMSDEP as we requested VMI support</u> in our proposed resolution. Veterans Services, Police, Fire and other organizations also provided almost unprecedented formal support. These include, but are not limited to, the attached letters from The Fraternal Order of the

Police, Virginia Professional Firefighters, the Joint Leadership Council and a National VSO Letter signed by the leaders of the following organizations; Elizabeth Dole Foundation, Tragedy Assistance Program for Survivors (TAPS), National Military Family Association (NMFA), RallyPoint, Dixon Center for Military and Veteran Services, Jewish War Veterans of the USA, Psycharmor, Independence Fund, Military Spouse Chamber of Commerce, Partners in PROMISE, Spouse of the 19th Chairman of the Joint Chiefs of Staff, Project Sanctuary, Women in Military Service for America Memorial Foundation, Camp Corral, Code of Support Foundation, No Greater Sacrifice Foundation, Our Military Kids, Blue Star Families, SEALKIDS, Inc, Operation Homefront, Student Veterans of America, Soldiers' Angels, Military Family Advisory Network, Special Forces Shield Maidens, Women Marines Association, Travis Manion Foundation, Navy Seal Foundation, The Green Beret Foundation, Service Women's Action Network, Wounded Warrior Project. Given the continuing deadlock and political maneuvering within and between the various political factions in Richmond, the BOV <u>must act now</u> by passing our proposed resolution.

- 5. The information provided to us by VMI Alumni and other groups clearly shows that, starting in 1839, VMI operated innovative and valuable programs similar to and including VMSDEP that can be a model not only for VMI but for all schools in Virginia. We can benchmark them as we work together to increase the program's Return on Investment (ROI) while mitigating financial and other impacts.
- 6. The actions by the BOV tomorrow on our resolution will be a defining moment for the Institute. Failure to join the growing coalition of groups and veterans by passing our proposed resolution or delaying it for further study, will amount to VMI denying it.
- 7. An empty resolution, deferring it to the September BOV meeting, or merely stating VMI supports veterans without taking the stand to solve the problem is unacceptable. VMI's history has been one of standing for what is right even if as a singular pillar of honor and moral courage. If the BOV chooses not to act VMI will surely stand-alone. <u>This time on the wrong side of honor and history.</u>

Statement on the Virginia Military Survivors and Dependents Education Program (VMSDEP)

May 29, 2024

The Joint Leadership Council of Veterans Service Organizations (the JLC) met on May 29, 2024.

The JLC members voted unanimously to request that the Governor and General Assembly call a special session to postpone the upcoming changes to the Virginia Military Survivors and Dependents Education Program (VMSDEP) pending study of the premises for the changes and their impact.

Much of the deliberation for these changes occurred without public input or dialogue. This issue is too important to decide behind closed doors.

Executive Directive Seven established a taskforce to review the changes and to help minimize the impact on military and veteran families.

Given the significant impact on our military families, it is crucial that we take the time to reassess these changes thoroughly.

We must act before July 1, 2024 to mitigate the impact on this year's students.

Dear Governor Youngkin and Members of the Virginia General Assembly:

As national organizations representing veterans, caregivers, and survivors, we write to you today to strongly urge you to repeal the recent changes to Virginia's Military Survivors and Dependents Education Program (VMSDEP). These changes were made "in the dark of night" during the budget process, rather than in the normal course of legislative business, setting a demoralizing national precedent for rolling back veterans' benefits just as the full cost of war hits home.

Prior to the recent changes, VMSDEP offered a full waiver of tuition and mandatory fees for those rated 90% or 100% disabled and the families of those who were killed in action, died on active duty, or who died as a result of their service-connected conditions. It was one of the most generous programs in the country for survivors and dependents, drawing veterans and their families to the Commonwealth and signaling Virginia as a leader among states in supporting veteran families.

Unfortunately, the budget language signed by the Governor greatly reduces this earned benefit, requires burdensome paperwork, and restricts the benefit to undergraduate programs only, and it could result in some families being forced to pay a higher portion of the tuition. As a result, Virginia now has one of the *least generous* education programs for veteran families and survivors anywhere in the nation.

This is a truly shocking development, as Virginia has traditionally been both military and veteranfriendly. In fact, Virginia is home to more than 150,000 active duty service members and their families, more than 700,000 veterans, and the highest percentage of women veterans in the country. Those service members and their families account for more than \$103 billion in total economic impact and 11.3% of Virginia's GDP. Disability payments to Virginia veterans alone account for an additional \$5.6 billion per year.

The decision to go to war is not made at the state level, but states can and do provide a critical part of the safety net that allows our warriors to rest easy, knowing that their families will be taken care of if the worst happens. Virginia's recent changes shift the burden of war's consequences to those who have already paid the most, and those changes must be repealed. The eyes of the nation are upon the Commonwealth.

Members of the Virginia House of Delegates,

I am writing you in my role as President of the Fraternal Order of Police of Virginia, Virginia's largest organization of law enforcement personnel, to urge your support for HB 6003, which the House is voting on this Friday, June 28.

HB 6003 restores a critical state program, the Virginia Military Survivors and Dependents Education Program (VMSDEP), which was cut in the May Budget. VMSDEP benefits the sons, daughters, and spouses of killed and disabled service men and women. HB 6003 also *strengthens* a similar state program that assists the families of first responders killed in the line of duty.

We appreciate the hard work of Chairman Luke Torian and the bipartisan group of Chief Patrons and Patrons of HB6003, as well as the support of Speaker Don Scott and Leader Todd Gilbert. Virginia made promises to our military personnel and first responders that should be kept.

Additionally, I hope proponents of "skill" gambling machine legalization will not try to hijack the special session by proposing legalizing these machines. When operational, these "skill" slot machines increase loitering, crime, and money laundering and have caused confusion among Virginia's law enforcement professionals. Legalizing slot machines in convenience stores, restaurants, and bars would be a poor policy decision for the Commonwealth.

This Friday, please keep the focus on assisting grieving sons, daughters, and spouses of fallen and disabled military personnel and first responders and avoid further consideration of convenience store slot machines.
