

**WILLIAM & MARY  
FY 2024 GRADUATE AND PROFESSIONAL PROGRAM TUITION**

Consistent with tuition and fee authority granted to William & Mary in the Code of Virginia, the attached graduate and first professional tuition are recommended for approval by the Board of Visitors.

The attached tuition schedules recommend a 3.7% increase to tuition for general graduate students regardless of domicile status for FY24 consistent with the institution's six-year plan submission. Increases to School of Business programs are largely a result of two factors: market analysis comparing W&M's tuition to competitors, and increased costs to delivering programs. The Military MBA increase is the result of a negotiated Memorandum of Understanding for a new rate for 2023-2025. Similarly, the Law School's tuition lags peer institutions, and the requested increase would position the Law School to optimize on its mission, support the university, and continue to advance in national rankings.

**WHEREAS**, the proposed increases to graduate and professional tuition result from analysis of the cost of programs along with comparison to market competition;

**WHEREAS**, the Law School continues to minimize the impact to existing students by applying a larger increase to incoming students to address market competitiveness while reducing class sizes, expanding financial aid, recruiting and retaining top faculty, increasing student support, and advancing in rankings; and

**WHEREAS**, setting tuition early in the admissions cycle is important to our graduate and professional schools in crafting financial aid packages and optimizing student yield;

**THEREFORE, BE IT RESOLVED**, That the William & Mary Board of Visitors approves the Graduate and Professional Tuition outlined in Tables 1-3 for FY24; and

**THEREFORE, BE IT ALSO RESOLVED**, that the Board will adopt comprehensive fees for students of all schools at its regularly scheduled meeting in April 2023.
